# General Information Community Land Use Permits

### **SURVEY/PETITION**

Survey - To establish a database via the observation of behaviours or the collection of information towards attitudes on products and services in the public realm (1)

Petition – The collection of signatures to oppose/support a particular purpose in the public realm

The following item/s must accompany a completed application form:

- Statement addressing the purpose the information is being collected
- Sample of the Survey or Petition Documents

#### **BUSKING**

Busking is a person (or group of people) performing in public in exchange for donations. Musicians, actors, street performers.

For the safety and wellbeing of everyone, the following criteria apply:

- performers under 16 will only be permitted to busk outside school hours and during daylight hours and must have written permission from a parent or guardian
- if under 12 years of age, the performer must be constantly supervised by a parent/guardian
- the busking permit is for valid for one month

The following item/s must accompany a completed application form:

- personal details such as name, address, phone and/or email
- 1 x photo identification (eg. drivers' licence, passport, student id card), or
- 2 x non-photo identification (eg. Health Care Card or phone/utility bill).
- Map of proposed location showing setup of structures
- If the performer is under 12, parents will need to apply, and the permit issued using your details, therefore
  please provide your own ID

#### **FREE SAMPLES & BUSINESS PROMOTION**

The distribution of free samples to the general public and/or to undertake business promotional activities in the public realm

The following item/s must accompany a completed application form:

- Sample of item/s to be distributed (if applicable)
- Plan showing setup of structures (if applicable)
- Details/images of structures (if applicable)

# **PREACHING**

Groups or individuals may preach religious or moral beliefs within public areas, however they must first apply for a Community Land Use permit.

For the purpose of a permit the following definitions apply:

**Preaching** - to proclaim, advocate or impress asserted religious or moral truth and right conduct in speech or in writing.

**Proselytising** - to convert or attempt to convert or recruit a person.

The following item/s must accompany a completed application form:

- an example of any material to be handed out
- a Certificate of Currency of your Public Liability Insurance with a minimum cover of \$20 million
- a form of government issued identification such as Drivers Licence, Passport or student card for all people noted on the application (maximum of four people).

# **PEDESTRIAN ADVERTISING**

The activity of carrying advertising generally, but not limited to, slung over the shoulders in the form of a sandwich board or similar in the public realm. Literature distribution is not permitted.

The following item/s must accompany a completed application form:

• Sample of the advertising artwork

#### STREET TRADING

Activity of selling unique goods and services in the public realm. This is only a once off, if a shop owner, an Outdoor Trading Application must be submitted.

The following item/s must accompany a completed application form:

• Map of proposed location showing setup of structures

#### **COMMERCIAL FITNESS ACTIVITY**

To undertaking Commercial Fitness Activities in the public realm.

The following item/s must accompany a completed application form:

- Map of proposed location showing setup of structures
- Professional registration with Fitness Australia, the national health and fitness industry association
- Public Liability insurance policy to a minimum of \$20 million
- Professional Indemnity insurance to a minimum of \$5 million.

The following activities are not permitted at any time:

- activities within playgrounds and on picnic benches
- martial arts (unless covered by separate insurance)
- the use of logs

• the use of resistance machinery and heavy weights such as bench/leg presses

Please note the following areas/facilities are not permitted for use at any time:

- picnic sheds and benches
- exclusive use of public outdoor fitness equipment in parks and reserves
- areas within 10 metres of memorials
- areas within 10 metres of any playground or item of play equipment
- areas within 10 metres of any public change room, toilet or kiosk
- areas within 50 metres of any neighbouring residential property

I have read the On Street Activities and Occupation of Parklands Policy.

(1) The **public realm** embraces the external places in our townships that are accessible to all. These are the everyday spaces that we move through and linger within, the places where we live, work and play.

I agree to all the conditions that the Council may determine and attach to the permit.  I have attached a copy of Public Liability Insurance Certificate of Currency with a minimum of \$20 million									
coverage. I confirm that the insurance attached is adequate in providing the appropriate insurance cover									
for the permitted activity. I understand that Council holds no responsibility for determining the validity of									
the insurance provided.									
I have provided a detailed description of my requested area of use.									
I understand that the permit does not provide me with exclusive use of the site and as such, I acknowledge									
that other traders or activities may be located in relatively close proximity to the location of this permitted									
activity.									
I understand that this permit application is not consent to undertake the activity until such time as I									
receive a copy of the signed permit by Copper Coast Council.
