in the Copper Coast; but at the same time accommodate the needs and expectations of current times. I appreciate and am reminded constantly that some of these ventures are seen by some as a waste of money, a waste of effort or simply not needed; but at the same time see the excitement; the enthusiasm; the enabling that this infrastructure investment is providing.

The need to improve the boat launching facilities at Port Hughes has been a topic of discussion for more than six years. The boating industry; the recreational and professional fishers; the tourism industry; and even the emergency service groups such as Sea Rescue had been calling for something to be

done about the Port Hughes boat ramp and facilities. The process from working party discussions through to construction has been tedious; at times delicate; frustrating; exasperating and also at times a departure from reality. Yet persistence; compromise and good planning have enabled this work to be undertaken, with barriers now down and boats able to utilise the expanded launch facilities with deeper waters. This will provide a safer facility for its users; be an enabler for the tourism industry and I am confident will provide some additional employment opportunities.

If our working party and Infrastructure team had not been prepared to consider and appreciate the work of our forefathers; listen to local knowledge; while accepting advancements in design and construction techniques – the barriers would still be in place. This same scenario could be paralleled with many of the other infrastructure works that are highlighted throughout this edition of the Copper Post.

Then we can also acknowledge the many successes of our schools from both the students and teacher's perspective over the past year. We are fortunate that the Copper Coast can boast schools that are providing our students with a high level of education that mirrors or in some cases surpasses those of the city.

There have again been some high achievers from our year 11 and 12 classes and both the students and those who have been their teachers should really feel rewarded and proud. I am confident that in time we will learn that many of these young people will go on to be leaders in our community or portray successes in the future in their chosen fields and careers.

But again the barriers that once existed between education opportunities in regional communities compared to the city have been broken down. No longer does a student need to leave the Copper Coast to be afforded a good level of secondary education, it is at their doorstep. However, I believe that we need to strive to gain opportunities around a variety of tertiary education options being deliverable in the Copper Coast. Recently I was miffed as to why our conventional universities are offering such courses as a Masters in Agriculture from a campus in metropolitan Adelaide. Surely such a course could be deliverable in an agricultural heartland and what better place than the Copper Coast! I can't accept the perceived obstacles to such a venture, we need to look at a wider picture and approach the concept with how it can happen rather than be confronted with why it can't.

It is this approach by local Kadina Memorial School Principal Dean Angus who was recently recognised as the state's top leadership category in the SA Excellence in Public Education Awards. His leadership style involves a proactive approach, where he puts in place plans; doesn't distance himself from his students and staff (where I have been constantly amazed when he can recognise a student by name in such a large school community); and had involved himself and the school with the wider community.

Dean Angus played an integral part in the success of gaining funding for the redevelopment of the Copper Coast Sports and Leisure Centre. His school; although he will be taking on a wider Regional Directorship within the Department for part

# MOONTA COMMUNITY WASTE MANAGEMENT SCHEME (CWMS)

A large section of the CWMS gravity network within North Moonta has been completed. Maria Court, James Place, Hooper Court and a small section of North Terrace are the only sections of gravity drain remaining within the entire project.

Connection crews have predominantly been focusing their efforts within the Moonta Bay areas between East Terrace and Marine Parade.

With the completion of property connections in areas of Moonta Bay, properties have become live alleviating some historical issues. Additionally the completion of works in various areas have allowed for road resealing within sections of the Moonta CBD. Road reinstatement works were recently completed in December within Moonta Bay for both the sealed and unsealed sections of road.

# It is Now Time to Connect for No Additional Application Fees

Remember that during the first 5 years of the project there are no additional application fees to connect and that the development of your land will be more flexible once you have connected as you will no longer need land quarantined for septics and soakage areas.

#### PORT HUGHES BOAT RAMP

Improved weather has enabled a focus on the new six lane boat ramp with all concrete works, pile works and pontoon installation complete.

Councils contractor has developed a new methodology which allows the boat ramp to remain open at all times with no closures until completion.

There will be some minor inconveniences to boat users and all boat users will need to use the facility with care throughout construction however boats will be able to launch throughout the entire construction



#### PORT HUGHES CYCLEWAY

The next section of the Port Hughes cycleway project from Harrys Point Road through to Snell Avenue Port Hughes, was completed in early November. The last section of this project, connecting the new path to the Port Hughes will foreshore, be completed 2017 in scheduled around the Port Hughes boat ramp project.





# ROAD RESEALING

Throughout December approximately 200,000m2 of reseal works have been undertaken within the Copper Coast. One of the Copper Coasts key connecting roads, the Thrington Road had road upgrade and sealing works within November to the western section of the road from Kadina-Cunliffe the intersection through to North Yelta, totalling approximately 12kms. In addition to this section of road receiving a new two coat seal, sections of road have been milled, reshaped and stabilised, together shoulders re-established, storm water upgraded intersections improved. Of note with the intersection improvements will be the addition of rumble strips on both approaches at the Kadina-Cunliffe intersection. Line marking, including edge lines, together with some vegetation management and signage upgrades completed this project in December 2016.

The 3km section of Tickera Road from Ellis Road through to the Spencer Highway will receive similar works to the Thrington Road, scheduled for January-February 2017.







## COPPER COAST SPORT AND LEISURE CENTRE

The improved weather has allowed for increased activity within the site. Excavation, electrical and plumbing contractors have been prominent.

Concrete contractors have followed these various trades with the steel work and have started pouring the concrete footings. The completion of many of the footings has allowed for tilt up wall panels to be erected.

Roof cladding contractors started in December with upgrading the existing roof area of the remaining buildings.





#### KADINA CENTRAL BUSINESS DISTRICT REDEVELOPMENT

Construction of stage 1 began on 21st of November 2016.

Stage 1 consists of stormwater pipework across the town centre and the upgrade of Frances Tce. This will prepare the town for stage 2 which will be implemented in 2017.

Stage 1 will pause from the 16th of December to the 11th of January to allow for the Christmas trading period. The aim is to have stage 1 completed in May 2017.

Residents are reminded that Kadina will be open for business during the construction period, weekly prizes will be available for shoppers in the redevelopment zone. For details visit a participating store in the Kadina CBD.

# Are You Prepared for the HEAT This Summer?

Here are some simple things you can do to reduce the impact of extreme heat:

- Stay Hydrated you should drink two to three litres of water a day even if you don't feel thirsty. Avoid "fizzy", alcoholic and caffeinated drinks and do not take salt tablets (unless instructed to by a doctor)
- Dress For Summer lightweight, light coloured clothing reflects heat and sunlight and helps your body maintain a normal temperature
- Check On Those At Risk visit at-risk individuals such as the sick and elderly at least twice a day and keep an eye on children. Watch for signs of heat-related illness
- Minimise Sun Exposure keep out of the sun as much as possible. If you must be in the sun, wear a shirt, hat and sunglasses. Also make sure you wear sunscreen to prevent sunburn, which limits the body's ability to cope with heat
- Prepare Your Home Prepare your home early. Service or replace your air conditioner BEFORE you need it. Curtains, awnings and blinds can also help to keep the home cool
- Make Use Of Air Conditioning if you don't have air conditioning, make use of public facilities such as shopping centres, art galleries, cinemas or other air-conditioned buildings. Portable fans are also useful in drawing in cool air, or exhausting warm air from a room
- Remember Your Pets pets can be particularly vulnerable to the heat. Make sure they have shade and plenty of cool water to last the day
- Seek Medical Advice If Necessary for medical advice telephone Healthdirect Australia on 1800 022 222. For immediate medical assistance telephone 000

# **Wallaroo Swimming Enclosure**

Throughout November all screw anchor installations, 96 in total, for the pontoon structure together with the piles for the gangway were completed. With the arrival of the pontoons, connection of these has commenced within the confines of the Wallaroo marina. The wave attenuators have been welded together on site and with the arrival of the swimming nets installation of the attenuators will commence in early December. The majority of the structural components for this project have arrived and throughout December installation will be undertaken and is scheduled for completion in January 2017, weather permitting.

Stage 1 is open and consists of new netting and a floating pontoon structure.

Stage 2 will get underway in the coming months and will include water activities. A number of people have volunteered to be involved in the stage 2 working group and we appreciate them offering their time to be involved in creating this important community asset.

# **Storm Damage**

The Copper Coast will feel the effects of the two 2016 storm events for years to come. While the first round of repairs have been completed there are a number of coastal areas, such as south of the Port Hughes jetty that will need a large amount of reconstruction work over the next few budget cycles. This area along with parts of Moonta Bay will need to be protected by rock walls similar to the section built to the north of the Moonta Bay caravan park.

Council is also working with a number of private residents that are building their own rocks walls. These walls will be constructed in a uniform manner to improve aesthetics and to reduce any risk to the community.

Other impacts from the storm included damage to beach access stairs, the Moonta Bay swimming enclosure, street furniture and coastal paths.



#### **MOONTA BAY SWIMMING ENCLOSURE**

Works to complete the storm damage will be completed in early February. Due to the amount of coastal damage, the marine experts have been inundated with work and we have had to wait in the queue to have the repair work completed.



# Can I Remove Native Vegetation?

Native vegetation in most parts of South Australia is protected by the Native Vegetation Act 1991. Native vegetation refers to any naturally occurring local plant species that is indigenous to South Australia, from small ground covers and native grasses to large trees and water plants. It also includes naturally occurring regrowth and in certain circumstances, dead trees.

Under South Australia's legislation, clearing or removing native vegetation must be avoided, minimised and/or offset. If clearing is unavoidable, you must seek the approval of the Native Vegetation Council or meet the requirements of the Native Vegetation Regulations The Native Vegetation Regulations allow certain clearance activities to be exempt from the Act. The types of activities that are exempt are set out in the Regulations. A guide to the Native Vegetation Regulations 2003 clarifies what is and isn't permissible

in relation to clearing native vegetation.

If you want to clear or remove native vegetation you need to comply with certain requirements (such as following guidelines) or apply for approval. You may need to seek approval or meet certain requirements to:

- cut down, burn, poison or remove native plants
- remove branches, limbs, stems or trunks
- slash understorey
- build a house or structure
- "tidy-up" an area of native plants
- change grazing practices
- carry out any other activity likely to cause damage to native vegetation.


# 2017 COPPER COAST VISITORS GUIDE

# **Financial Summary**

The table is a summary of the audited financial results of Council for the past two years and the adopted budget for 2016-17. The operating surplus for 2015/16 was primarily due to the \$1,768,000 revision in the landfill provision account which was consequently recognised as income. There was a change in the provision for the reinstatement of the landfills due to the revised calculations and closure plans being near completion as discussed further on in this article. The provision is based on estimates provided by consultants and the final closure plans are still being negotiated with the relevant state authorities. The resultant liability will be reduced over a number of years yet to be determined in conjunction with the EPA.

The impact of this revision was offset however partially due to an increase in depreciation to recognise depreciation on amounts previously not depreciated as they were residual values on our roads. The AASB (Australian Accounting Standards Board) re-affirmed the definition of residual value as being the future sale price of an asset (emphasis on sale as a mandatory requirement). This meant that applying a residual value where no financial consideration is received for infrastructure assets such as "in-situ materials" for roads was an incorrect application under the Accounting Standards. This affected a number of Councils as they have been using residual value to recognise the value of materials salvaged in situ on reconstruction of roads, thereby acting as a proxy for the long life components of roads. The additional depreciation in the Statement of Comprehensive Income impacts the bottom line and with it the Operating surplus ratio.

There was no advance payment of the Commonwealth Financial Assistance grants in 2015/16. Advice received late in June 2015 advised however that the first two quarters of the 2015/16 payment would be paid as an advance payment on the 28th June 2015 and therefore recognised as income in last year's results.

## Where do the funds come from?

Council receives some funding in grants from other Governments and raises some funds in user fees and charges, however about 71% of

revenue comes from the Council Rates.

The pie chart (below) outlines the areas in which Councils receive funds in a typical year.

# How is the money spent?

Council provides many services to the community, some of which are legislated and others which are provided by choice. Many of our services are largely invisible (ie storm water management, community wastewater management schemes), but are definitely a necessary service provision.

Council's expenses represent the cost of providing these service to the community. Materials, contracts and other expenses made up 34% of the total operating expenditure of Council. Council Employees are its most valuable asset and provide the numerous services listed for the community at an operating cost of 26% of expenditure. Depreciation makes up 34% of the total operating expenditure. During 2013/14 Council increased the provision for the reinstatement of the Kadina & Moonta landfill sites and this correspondingly increased the Materials, contracts & other expenses component of expenditure by \$5.8 million. The provision (liability) was reviewed during 2015/16 and reduced by \$1,768,000 in 2015/16 as revised estimates have been received and closure plans being worked through with the EPA for finalisation. This reduction in the provision was recognised as "other income" during 2015/16.

Whether a service is a legislative requirement of Councils, or is provided by local choice, the Local Government Act requires that a Council is "responsive to the needs,

## What assets does Council own?

When looking at the Council Balance Sheet the Council assets totalled \$285.1 million. This includes money that is owed to Council in the form of Rates and other services (Trade & other receivables), stock on hand (inventories) and for the large

proportion Infrastructure, Property, Plant & Equipment.

Council's non current assets (Land & Improvements, Buildings and Structures) were revalued by Maloney Field Services in 2015 at fair value. Council's CWMS schemes were revalued by management as at 30 June 2015 at fair value and cost. Additions to these assets from this date have been measured at cost. One of the challenges facing Local Government today is finding the revenue required to maintain the large amount of community infrastructure under its care and control.
