Community Wealth - more than bricks and mortar!

Each year Kathryn and I attend over 420 engagements, and this has allowed us the opportunity and pleasure of sharing the lives of many within our community. But it also exposes us to the needs of our community – those needs are varied. Council have to take responsibility for many but some lay at the feet of the wider community.

There is no doubt as I move around the Copper Coast, I am constantly reminded of the huge contributions made by individuals, groups and organisations to the Copper Coast's social infrastructure. We so often hear and consider our built infrastructure, but what would our community be without social infrastructure – like a body without a soul!

I have on numerous occasions, with a degree of chastising by Kathryn, referred to the “un sung hero’s” of the community; and there are many who should gain recognition and don’t, but nor are they looking for it – they just go about their work and deeds with quiet achievement, with satisfaction that they have made a difference.

Meals on Wheels brings together volunteers who give freely of their time, in Moonta’s case, cooking a meal five days a week and then like Kadina and Wallaroo deliver a three course hot meal to those people who are unable to prepare a sustainable meal for themselves. Many elderly of our community could not maintain their degree of independence if they

did not have the service of Meals on Wheels. However, when taking a turn on the delivery roster in August this year, I found in many cases that the brief chat with the volunteer deliverer made the difference in what could have been an isolated day.

The Yorke Peninsula Passenger Transport Scheme and associated bus, with the assistance of volunteer drivers from the community enables so many elderly or restricted people to access the very best of medical services not only in the Copper Coast but also in Adelaide. The community cars allow people who don’t have their own access to get to appointments, shopping or just an outing.

While our Council assist with the provision of vehicles, the scheme would not be financially sustainable without the volunteer drivers. Yet I am constantly told that these volunteers are not just drivers, but confidants; they are carers; a listening ear; a support; even a comedian – making a difference in what could be a very traumatic day for some.

Wastewater treatment plant



The new wastewater treatment plant on Retallick Road, Port Hughes is nearing completion. This new mechanical plant is capable of treating full sewer and effluent (the discharge from septic tanks). Once it is fully operational it will supply treated water for irrigation. The water will initially be used on the Moonta football oval and will offset thousands of dollars currently spent with SA Water. It also has the Moonta Golf Club excited about the prospects of utilising the water on their golf course.

The designs for stage one of the CWMS drainage project have been completed, with an information session held on the 10th of October for those properties involved.

Tender documents are finalised and will be advertised in the coming weeks as the main task now is to find a contractor to complete the physical works in the new year. One of the first tasks for the contractor will be to peg out the connection points at each property, this will give you a

physical reference point to work from and allows you to ensure that the point is in your preferred location.

We are planning to have the designs completed in the first quarter of next year for the properties in the next stages. We will then conduct a repeat of the information sessions similar to those held for stage one.

Our website contains all the latest information and copies of the designs and will continually be updated as the project progresses.

Pigeons

An ongoing pigeon culling operation is having an impact, as numbers are being reduced by the thousands. A range of initiatives are underway including;

- Ongoing alphaclorolose culling
- A new net cannon blaster
- Investigating birth control options that exist overseas.
- Controlled shooting

The pigeons have been a constant distraction to the visual appeal of the paths and buildings within the Copper Coast and causing ongoing damage to public and private property. This regular program will hopefully ensure reduced number of pigeons within the Copper Coast for the foreseeable future.

School Holiday Activities for children aged 4 to 12 years every school holidays at Kadina & Wallaroo Libraries. Contact the libraries or check the Council website for further details.

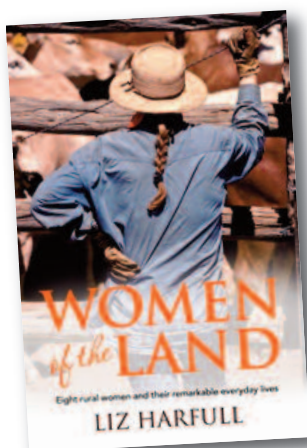

Port Hughes Boat Ramp Update

High praise for new proposal

The proposed layout for the new boat ramp has received praise and is believed to address many long standing issues:

- The entrance to the breakwaters is in much deeper water, and is directly from the west, negating the beam on orientation of vessels in shallow water (breaking waves).
- The entrance is in deeper water, and closer to/into the weed covered area. This will greatly reduce any sand movement at the seabed. Hence, reduce siltation.
- The entrance faces west, not north, hence it is not as likely to collect floating sea grass. This is proposed to be checked using a computer based numerical simulation model to ensure that this is the case.
- With the new orientation the boats are towed in from the west, around a small dog leg, and

again west directly onto the ramp. This is a much easier and safer process.

- Sand accumulation inside the harbour is likely to be much lower given the revised orientation of the opening, and the breakwaters extending further out.

Work continues on new designs

To progress from a concept plan to a full design and then to achieve planning approval has many steps. We now have a consultant on board who will be undertaking the necessary work to prepare a planning application to be lodged with the State Development Assessment Commission. This will include a number of steps and referrals to all the relevant state agencies, it will also include a public consultation process and information sessions.

Some of the items the process has to cover include:

- Full engineering designs
- Possible effects on the downstream beaches/cliffs and potential impacts on local beaches.
- Modelling and/or assessment of wave-induced sediment transport.
- Dredging method and mitigation strategies proposed to manage turbidity and other environmental impacts during dredging operations.
- Details on the proposed water quality monitoring program.
- A Construction Environmental Management Plan (CEMP).
- Environmental Impact Assessment of sensitive seagrass in the location and mitigation strategies.

The process is very thorough and covers all aspects of the proposal.

Owen Terrace

Work is progressing with the Owen Terrace redevelopment in Wallaroo. The supermarket developer is finalising their plans, in preparation for the lodgement of a development application, in conjunction with the Council working on the design of the planned upgrade of Owen Terrace. The initial drafts are looking great and we hope to have plans on public display before Christmas.

What is a septic tank?

A septic tank is an underground watertight tank which is usually divided into at least two compartments. The first compartment provides for sedimentation, sludge digestion and sludge storage. The second compartment is designed to prevent the discharge of any sludge that may escape the first chamber.

The septic tank performs three functions:

- It acts as a settlement chamber for solid materials.
- It allows some bacterial breakdown of waste materials to occur.
- It acts as a storage chamber for undigested solid materials which must be removed periodically (usually every 4 years).

Health caution: Septic tanks do not kill pathogenic bacteria, viruses or parasites. Septic tank effluent must be treated with extreme caution and contact with people, food, clothing and pets must be prevented! Do wear protective clothing and wash your hands!!



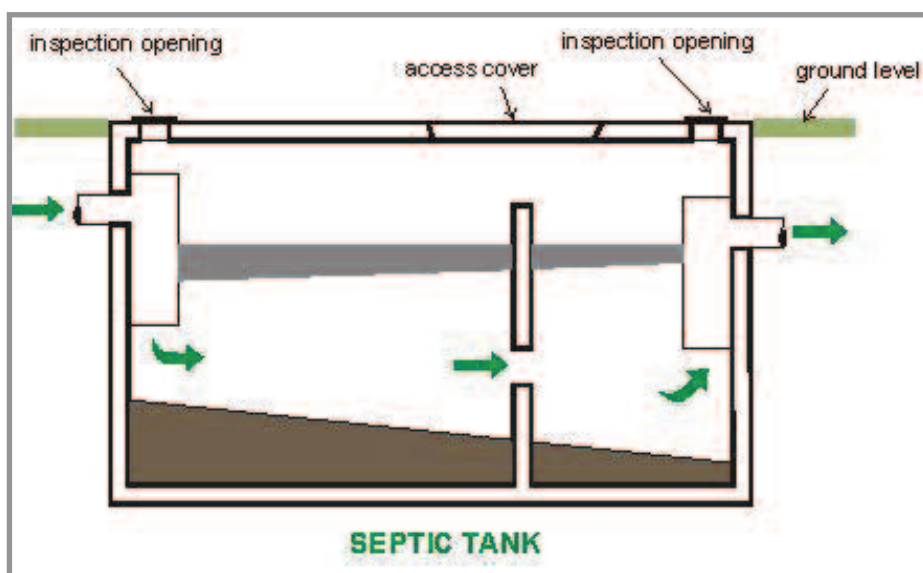
How does a septic tank work?

On entering a septic tank, the sewage solids and other waste matter separate out of the liquid, some floating and others sinking. Anaerobic bacteria attack the solids converting much of them to a liquid or gaseous state and leaving a humus-like residue. This residue, together with grit and other heavy material, separates out and forms a sludge at the bottom of the tank. Some of the solid matter remains in the surface scum.

In a correctly sized septic tank the liquid portion (effluent) passes out of the tank after approximately 24 hours. This effluent is relatively free of suspended solids and is therefore more suited for disposal into the ground by means of absorption or transpiration trenches, or for further treatment at the Council's Wastewater Treatment Plants.

Maintaining your septic tank:

- Remove accumulated sludge from the tank.
- Generally, septic tanks require periodic cleaning or pumping out of accumulated solids every 4 years. If solids are allowed to build up in the tank to a point where they pass to the effluent treatment stage they can cause problems. If your house is connected to the Community Wastewater Management Scheme (CWMS), Council will arrange to have your septic tank cleaned and inspected once every 4 years.
- Minimise or manage the volume of water entering the system.
- Ensure water from roof downpipes does not enter the system.
- Install water saving devices such as shower heads that minimise water use and dual flush toilet cisterns.
- Regularly check plumbing fixtures for leaking taps or toilet cisterns. Have them repaired.



- Ensure the system can be readily accessed for maintenance.
- If your house is connected to the CWMS you must install an approved access shaft to provide access to both chambers of your septic tank. If you own a house that is not connected to the CWMS, and it was built prior to March 1995, you may consider installing an access shaft to minimise future maintenance difficulties.
- Do not construct driveways, buildings or paved areas over the septic system as this may result in damage to the system and access problems when the tank requires pumping out at a later date.
- Use household detergents and bleaches sensibly.
- The normal use of household detergents and bleaches is considered satisfactory.
- If you have an aerobic wastewater treatment system or sand filter, follow the manufacturer instructions for these systems.
- If in doubt about any household product suitability, consult the product manufacturer.
- Don't use the system for the disposal of chemicals.
- Don't dispose of medicines or strong chemicals such as pesticides and paints into the septic system. This can cause the septic tank to malfunction and may pollute groundwater.
- Prevent mosquito breeding.
- Ensure that all vents associated with the system are fitted with mosquito proof mesh and access openings are correctly sealed.

Bushfire prevention

It's the lead up to that time of the year again, summer, and with it comes The Fire Danger Season!

Now is the time to take pre-emptive action if you haven't already done so, to ensure that your property is cleared prior to the commencement of the fire danger season and is maintained to the required standard for the duration of the season.

At this time of year vegetation can become overgrown, creating fire hazards. In order to reduce the potential danger until the expiry of the fire danger season:

- If the property is under one hectare in area, all undergrowth should be maintained at or below 10cm in height
- If the property is over one hectare in area, establish and maintain a fire break

around the whole area, placed as near as practicable to the perimeter. The fire break shall be at least a 5 metre wide strip on which all grass, pest plants and undergrowth is reduced to a maximum of 10 centimetres.

Council's Fire Prevention Officer (s) have recently sent out reminder letters to property owners. As of the 8th October, 2012 inspections will be carried out on properties within the District Council of Copper Coast.

If these properties have not been cleared a Section 105F notice will be issued with 21 days to rectify. Council then has the right to remove or reduce a fire hazard on private land and recoup the costs from the property owner and issue an expiation notice.

ENVIRONMENTAL HEALTH GUIDE

IS THE WATER IN YOUR RAINWATER TANK SAFE TO DRINK?

Rainwater from your roof can be a valuable resource and can be quite safe to drink when stored in a properly installed and maintained water catchment system.

WHAT HAPPENS TO THE WATER IN YOUR TANK?

- Heavy materials in rainwater settle on the bottom of the tank and form a thick layer of sludge.
- Rainwater generally contains few chemicals.
- Micro-organisms from the roof or gutters can build up in the sludge layer.
- Most micro-organisms are harmless and do not pose a health risk. However, some organisms commonly found in rainwater tanks can cause stomach aches, diarrhoea and similar ailments and can be quite dangerous for the very young and the very old.

HOW TO REDUCE POLLUTION

- Roof catchments should be kept clean and clear of leaves.
- Cover the inlet and turn the down pipe to one side so the water from the first good rain rinses down the roof and gutters, then runs to waste.
- The inlet and overflow of the tank should be screened with a mesh to prevent birds, animals and insects from gaining access to the water.
- A well maintained leaf trap will reduce the amount of organic matter that enters the rainwater tank through the inlet.
- The tank should be covered to prevent light from reaching the water as it will encourage the growth of bacteria. The cover should have a tightly sealed manhole, to allow access to the tank for cleaning and inspection purposes.
- Use only "food grade" plastic pipe and fittings if you intend to drink the water.

HOW TO MAINTAIN YOUR TANK

Proper maintenance of the tank, catchment system, roof, gutters and inlet is essential to ensure a safe supply of water. This is best carried out before the rainy season. You should:

- clean the gutters and tank inlet every three or four months;
- remove the sludge every two to three years (desludging).



Gutter cleaning is not complicated but don't tackle it alone; seek the help of another person to hold the ladder, pass any equipment, etc.

DESLUDGING

Tanks should be drained, rinsed with a hose and, if necessary, tilted to drain.

CHLORINATION

Regular chlorination of your rainwater tank should not be necessary. However, if you suspect the water in your tank is contaminated, it should be treated by adding swimming pool calcium hypochlorite (60-70%) or sodium hypochlorite (12.5%).

The initial dose to treat the contamination should be 7 grams of calcium hypochlorite or 40ml of sodium hypochlorite per 1000 litres of water in the tank at the time of treatment. The water should be stirred then left to stand for at least 24 hours to allow the chlorine taste and smell to dissipate. It is important that the chlorine you use is not stabilised.

To maintain a safe water supply after the initial dosage, 1 gram of calcium hypochlorite or 4ml of sodium hypochlorite per 1000 litres should be added to the rainwater tank weekly and allowed to stand for a minimum of two hours.

The water will be safe to drink provided the chlorine smell is not too strong.

It is important to mix the chlorine in a

plastic bucket **IN THE OPEN AIR** before adding it to the tank. Mix it thoroughly with the tank water.

DO NOT POUR WATER ONTO CHLORINE. ALWAYS ADD CHLORINE TO WATER.

VERY IMPORTANT

- Lead-based paint and flashings must not be used on the roof if it is in the catchment area for a tank which supplies drinking water.
- To stop mosquito breeding, put a cup and a half of liquid paraffin or lighting kerosene into your tank. This should be done at the end of the winter rains and again if the tank overflows. Both will evaporate over time, so check the tank a couple of times during the summer. Do not use power kerosene as it will taint the water.
- The inlet pipe should have a sieve guard to prevent birds or animals getting into the tank. After the annual clean out, the inlet should be firmly covered until it is time to reconnect the pipe.
