MAYOR'S MESSAGE...

Yes Minister!

I am often writing to Ministers of various portfolios of both the State and Federal Governments and always offer to further address the respective issues with actual discussion. I have always found personal face to face discussions more beneficial than an ongoing paper trail of letters or emails.

The benefits of face to face discussion are further strengthened if the discussions can actually be conducted locally where the Minister and his chief of staff are able to see personally the issues at hand and gain first hand experiences.

To that end I was heartened when the Minister for Local Government, the member for Frome the Hon Geoff Brock in his negotiations to support the Weatherill Government, gained agreement for regular Ministerial visits to regions and the ongoing rotation of Community Cabinet meetings throughout the State. Recently it has been our turn to maximise on this agreement and host with Barunga West, Clare & Gilbert Valleys, Port Pirie, Mount Remarkable, Wakefield Regional and Yorke Peninsula Councils, the Weatherill Cabinet and their chiefs of staff.

Hopefully we have maximised on this opportunity and been able to present to Cabinet the opportunities that we have if we can gain the support of State Government or witness the reduction of Red Tape that continues to obstruct development in our community. There is no doubt that all levels of Government have a genuine desire to progress development and create employment opportunities, however there is also a recognition that there are numerous administrative obstructions that make this pathway continually difficult.

Prior to my involvement with Local Government and in particular my closer relationships with State Government I didn't appreciate the true comedy of the English sitcom "Yes Minister". There are so many examples I have that have paralleled those episodes, that it is more like a "reality show" than comedy! On some occasions the issues that we face could be compared more closely with the current 'reality show' - "I'm a Celebrity Get Me Out of Here".



Health Care is always a topical issue. The new Royal Adelaide Hospital has dominated the media pages and I'm sure Minister Snelling's daily calendar for several years. However, we could not allow the opportunity to pass with Community Cabinet and remonstrate the issues that face the health services of this community and in particular Wallaroo Hospital.

There is no doubt that as a community we are fortunate to have a health service of the level that we are afforded through that of the Northern Yorke Peninsula Health Service, but we also need to accept that it is stretched to its limits and staff are working under constant pressure. Minister Snelling and his staff can rightly point out that this is not unique to the Copper Coast, however we are asking that there is dialogue toward future resolutions

that face the health service and that the inadequacies are addressed. The ongoing growth of the Copper Coast will see the complexities that are presented to the health service increase and this is coupled with the increasing traffic for specialist services, Radiology and Obstetric services from not only the Copper Coast but the Yorke Peninsula region.

I think in one of the "Yes Minister" episodes Sir Humphrey boasted to the Minister about the very profitable hospital – which actually had no patients. We too have one of those in Kadina, as does Minister Snelling at the western end of North Terrace, but the reality for the Copper Coast is that we have a hospital that has an ever increasing number of patients, with a shrinking budget!

When we speak of budgets, there is often the view point that the expenses are calculated and then the needed income levels are set! This perhaps was the way that Sir Humphrey may have argued his budget strategy, however our Council as I am confident as are the State Government trying to minimise the increases to budget pressures and keep revenue levels down. Much of our presentation to Community Cabinet was about opportunities of reducing Red Tape and therefore reducing the costs of doing business.

Local Government throughout the state have for many years had the care and control of State Crown Land. In some cases this land has been regarded as surplus to requirements by both levels of Government but the methodology for disposal is long and convoluted. Over the past couple of years there have been opportunities to develop Crown Land for expansion to the industrial area of Kadina, and there needs to be a partnership approach to the State disposing of this land to allow industrial expansion, which can provide some further employment opportunities for our community while plenishing the state coffers.

There is considerable land along the disused rail corridors throughout our towns that is strategic for our community development, but restrictive in its procurement for community benefit. Hopefully Cabinet may give fair consideration to some of the opportunities outlined in our presentations that may perhaps see the removal of Red Tape by transferring

these parcels of land to Councils and use the power of the Local Government Act to ensure that it is managed appropriately.

An example provided, was that of the Paskeville recreation land and the water sustainability project that was undertaken by the Paskeville Progress Association, Sporting bodies and Council. This project was jeopardised because of the different ownerships of land parcels that have been used by the Paskeville Sporting bodies for many many years!

We provided the suggestion that perhaps Cabinet could consider as a way forward transferring any land to Councils that has been under Council care and control for more than 25 years or when a Council has maintained and improved the land over that period. Furthermore to ensure that the State is protected and is not deprived financially, we suggested that if any land was to be utilised or sold for commercial purposes at any time within a 20 year period following the transfer to Council, then the Council will commit to giving 80% of the profits from the sale of the land to the State Government.

There were a number of other issues involved with Crown Land that was for discussion and the reduction of Red Tape. The land associated with Stage 6 of the Marina has been waiting for Cabinet consent for near on 15 years. The road realignment of Heritage Drive, which will allow for additional car parking, enables the construction of a 36 room hotel; this has taken 6 years thus far. Six years we wait to create near on 200 jobs!

Yet on the other hand Council has care and control on behalf of the Crown, of the land under the Wallaroo Kindergarten, which is leased back to another State Government Department. The land should be removed from Council's care and control and granted directly to the State Government Department involved. A reduction of Red Tape – the removal of Sir Humphrey nonsense!

We are ever hearing the mention of being "over governed", however I am ever aware and respect the roles that each level of Government undertakes in our Federation, however there needs to be a mutual respect between the levels of Government and a maturity of trust of each other in the interest of those we serve. We need to forge partnerships, not build silos.

The opportunity to have presented to State Cabinet and have had meetings with Ministers and their respective department heads has reinforced the pathways for a strong future for State and Local Government relations – we just need to ensure that our pathway is clear and has firm direction. Enjoying open Government!

And with the consideration of open Government I again borrow a scenario from the sitcom "Yes Minister". The Minister asks for a new chair: "I'd like a new chair. I hate swivel chairs". His chief of staff replies: Minister, it used to be said there were two kinds of chairs to go with two kinds of Ministers: one sort that folds up instantly; the other sort goes round and round in circles."

One can hope that this was not the advice offered following our meetings with Ministers?



Moonta's CBD Master Plan

Council has been gearing up to commence with the preparation of a Master Plan study to plan for the future of the Moonta Town Centre and to address the many issues raised over time by the community in a coordinated manner. The study will involve the evaluation of the Town Centre, looking at the existing urban and landscape condition, vehicular and pedestrian traffic movement patterns, car parking, environmental and social values, cultural and heritage values and potential issues and opportunities.

To ensure the success of the study and subsequent implementation it is important that Planners, Urban Designers and decision

makers have a detailed understanding of the broader issues and opportunities for the Town Centre as well as a detailed assessment of the public realm within the Town Centre. To set the framework for the development of a design guideline, input from the community into all these matters is absolutely crucial.

As one of the first steps to progress the Plan a public meeting was held on Thursday, 23 March 2017 in the Moonta Town Hall. The main aim of the first meeting was to explain the way forward with this project to the general public and also to get a general understanding from the local community what their expectations are.

This meeting was a big success with more people attending than what was expected. We are really excited to see how much the local residents care about Moonta, wanting to be a part of this process to make it a great place!

Further opportunities will be available for people to have their say. The valuable information gathered at the meeting (as well as the information collated through the recent survey conducted by the Moonta and Districts Progress Association) will be used to formulate a survey that will be distributed to refine the ideas raised at the public meeting. This will be the next step to ensure the local community remains involved in the process.

It is anticipated that a draft Master Plan will be produced later in this year. The draft document will be advertised which will allow the general public further opportunity to comment prior to the finalisation of the Plan.

Copper Coast Sport and Leisure Centre We can report massive changes since the last newsletter. The redevelopment is now focused on the construction of the three new undercover courts. Precast concrete walls were erected to the eastern end of the building highlighting the size of the new facility. Structural steel has been erected and has formed the main framework of the building.

Celebrate our past and research your family and local history at your library.


The Copper Coast Library at Kadina holds an extensive range of research materials and items to assist with tracing your family history and information about the local area.

Due to our mining heritage the Copper Coast was home to the largest population outside of the city of Adelaide in the late 1800s and valuable information is available to assist those researching their past.

The collection is housed in the Local History Room and includes Births, Deaths and Marriages records, cemetery records, shipping records, family histories and other research records.

Although the resources are available all library opening hours the library is fortunate to have the support of the YP Family History Group who ensure volunteers are available to share their expertise and assist visitors with their research every Tuesday from 10am to 12noon and every Wednesday from 2pm to 4pm.

The month of May celebrates South Australia's History Festival and our local Kernewek Lowender Cornish Festival. Volunteers will be available additional hours to assist many who travel to our area and have family connections to the Copper Coast. How Your New Wallaroo Swimming Enclosure Works

The facility is made of two parts; the pontoons and the attenuators.


The attenuators (the 3 large black pipes) hold the nets and create a large safe swimming area.

The pontoons are positioned to create two swimming areas; a large 50mx25m and a smaller, shallower area that is 25mx9m.


They are designed to handle all known Spencer Gulf conditions. They are

designed to be very flexible so that they do not break. This means that when the sea is rough, the pontoons will twist and flex with the movement of the water. Therefore, in these conditions the enclosure gates will be closed and there will be no access to the facility.

The pontoons are connected to the sea floor by 64 large bungee cords (Seaflex). These cords stretch to allow for the rising tides and storm events.

Moonta Community Waste Management Scheme (CWMS)

The North Terrace gravity drainage network has been completed. This means that the entire gravity drains network (about 60,000 metres of pipe) are now completed for the entire Moonta, Moonta Bay and Port Hughes CWMS project.

We still have a number of property connections to complete before we can finally sign off on full completion of the project.

Now that the main sections of drainage works are nearing completion, we can start the rehabilitation of the roads in parts of Moonta Bay and North Moonta.

maintenance and will be completed with the planting of appropriate native species.


The final stage of the path is scheduled to coincide with the Port Hughes boat ramp carpark upgrade.

Port Hughes Boat Ramp

Over recent months the contractor has continued their work on raising and reshaping the southern breakwater.

The stage 2 coffer dam allows for water to

be pumped out and for basin excavations to begin. This will allow for the construction of the wharf area on the southern end of the facility.

District Council of the Copper Coast Annual Business Plan Summary 2017/18

The annual budget is a Council's statement of:

- Its intended operating and capital expenditure as well as revenue sources to give effect to its annual business plan; and
- Its projected financial position

Decisions in the annual business plan on matters such as project priorities and levels of service provision are subject to the funds available. Both documents are closely interrelated and the Budget gives effect to the annual business plan.

The Year in Review 2016/17

The 2016/17 financial year saw Council continue to focus on the renewal and replacement of infrastructure such as CWMS, roads, footpaths and drainage. Due to storm damage the focus was also placed on our foreshore assets.

Commitments to major projects and partnerships also continued to include:

Initiatives over more than one year;

- CWMS treatment plants and major infrastructure
- Closure and capping of the Wallaroo & Moonta landfill sites
- · Footpath program
- Foreshore Upgrades (including Port Hughes Boat Ramp)
- Upgrade of the Copper Coast Sport & Recreation Centre
- Upgrade of the Kadina CBD
- Additional budget allocation for Road Resealing Program
- Stormwater Plans
- Community Transport Scheme, and
- Provision of services to special needs groups.
 Legislation requires that Council provide certain services, however many of the services provided are also by choice, responding to the needs of the local community.

Key services provided are:

- Local Roads and footpaths
- Recycling and Waste Management
- Library Services including mobile library, computer & internet facilities
- Tourist information and support
- Aged care
- Dog and Cat Management
- Arts and culture
- Building and Planning
- Recreation and Sport facilities including ovals, picnic areas, open space, playgrounds, skate parks and bike tracks.

2017/18 Significant Influences and Priorities

A number of significant factors have influenced the preparation of the Council's 2017/18 Business Plan and Budget. These include:

• The combination of Consumer Price Index

(CPI) increases, Negotiated Enterprise Bargaining agreements and the fact that Councils do face higher cost increases due to the capital intensive nature of the goods and services purchased. Consideration is also given to the Local Government Cost Index, which measures the increase in costs for Local Government.

- Council understands (through a thorough ongoing assessment of our assets) the true cost of maintaining, upgrading and replacing our assets, this amount is substantially higher than what Council had been working to historically.
- Increasing fees and charges imposed by other levels of Government such as the State Waste Levy, etc.
- Requirements to maintain and improve infrastructure assets to acceptable standards, including roads, footpaths, stormwater drainage and community wastewater management systems.
- Service delivery & infrastructure needs for a growing population.
- State/Commonwealth grant funding not keeping pace with the increase in associated service delivery costs.
- No change to the announcement in the Budget papers in May 2014;
- South Australia's Supplementary Local Road Funding has not been extended beyond 2013/14. The supplementary funding commenced in 2004/05 as compensation for SA's unfair share (5.5%) of funding being received under the identified Local Roads Component of the Financial Assistance Grants arrangements.
- There will be no real per capita increase (ie to take account of inflation and population) in the national pool of Financial Assistance Grants for the next two years. This freeze commenced in 2014/15 however this funding had increased in real per capita terms each year since 1997/98. The indexation has not been reinstated as yet.

In response to these factors, and to minimise the burden on rate payers, the Annual Business Plan has been prepared within the following guidelines:

- The Annual Business Plan will result in the total revenue raised through general rates increasing by approximately 6% plus revenue from newly developed properties.
- Total operating expenses to be held where possible, within levels of the previous financial years and adjusted by the Local Government Price Index allowing above indexation increases to be allocated directly to maintaining community assets, such as stormwater infrastructure, roads and footpaths.

Further to these factors Council must consider that an increase to the service levels increases expenditure on a day to day basis. Council has budgeted for an operating deficit and this means that the current levels of services are higher than the income received which is not a sustainable position. It is however the aim of Council to achieve a balanced budget, meaning in balance between the community's desire for a higher service level and their willingness to contribute further to the income and past results have seen a positive trend towards this.

Revenue & Expenditure

Council has budgeted for an operating deficit of \$1,185,123 in 2017/18. The operating surplus/(deficit) measures the difference between operating revenue and expenses for the period and Council's long term financial sustainability is dependent on ensuring that, on average over time, its expenses are less than its revenue.

The Council's 2017/18 revenue is budgeted to be \$33,280,368 of which approximately \$16,160,600 will be raised from general rates, (excluding the NRM Levy & CWMS Service Charges). This is an average increase of 6% above general rates generated in 2016/17 plus the revenue generated by new assessments created during 2016/17. Council works to spread the rate burden fairly across all rate payers offering flexible options for payments of rates for those who need them.

Separate Rates

CWMS

In 2017/18 the separate rate for the construction of the Community Wastewater Management System in Moonta, Moonta Bay and Port Hughes will cease due to the project being completed and the CWMS service charge will now be in effect on these properties.

Commercial Development Levy

Not progressing on holistic Copper Coast rate as proposed in the separate rate report for a commercial development levy. However, in 2012/13 the local traders in the Kadina business district requested a separate rate to fund planning towards development in this area. It is now proposed that this rate will be continued to be raised against Kadina CBD businesses and these funds will be transferred to the Kadina Chamber of Commerce who will administer them. All properties rated will gain immediate membership to the chamber and be entitled to vote and be part of the decision making process for the funding.

The Dunes

The Council introduced in the 2013/14 financial year a new separate rate to partly fund the maintenance of the Port Hughes Golf Course (Dunes). This replaced the existing annual development levy that each land owner agreed to pay to the developer of The Dunes Port Hughes. This will continue.

Owen Terrace Verandahs

A separate rate was adopted to fund the replacement of the Owen Terrace Verandah's in Wallaroo in 2014/15 and this project was completed in 2015/16 however funded over a five year period up to and including 2018/19.

Riley Cove

During 2014/15 residents of the Riley Cove Community Corporation approached Council to adopt a separate rate to fund the internal road maintenance at the Riley Cove Village. This rate will continue for a period of 100 years and will be reviewed regularly during this period.

Moyle Street

Council is proposing a separate rate for the residents adjoining Moyle Street after their submission to Council was received requesting an upgrade to the road by installing kerbing. The proposal is that the residents will contribute 50% of the cost of the upgrade, estimated at \$80,000 over a 5 year period which is proposed at \$195 per property per annum. A total of \$975 contribution by each allotment adjoining the road.

Economic Development and Infrastructure Rate


Council is proposing to also implement a separate rate for land CT Vol 6059, Folio 235, 236, 237 and 243 which is threefold being for the construction of a road, Copper Coast Economic Development, including but not limited to the land and Copper Coast Marketing, including but not limited to this land. The rate would be applied in a single year, allowances will be made for it to be paid at the time individual allotments created from the Land are sold.


Waste

Council is also proposing a one off 1% additional increase (about \$12.50) in the residential and vacant land rates to enable the RRC (Resource Recovery Centre) to become free for residents who sort their waste. It will be a 2 year trial to combat illegal dumping and encourage a clean-up of the community. If this proposal is successful, it will potentially be the last year for green kerbside collection. This hasn't really had the take up needed to make this an ongoing service, and the free access to the RRC may make it less attractive in the future. Commercial charges will remain, as will charges for items like tyres and mattresses. We will also have a reduced rate for residents that don't sort their waste. It won't be free, however, it will be approximately a 33% reduction on the current gate prices.

Job Stimulus - Rating

To align with the State Governments Job Accelerator Scheme and to encourage the creation of the tourism products identified by the YP tourism audit we are proposing a general rate exemption for new job creating businesses. A three year initiative to encourage the development of new employment





opportunities in the Copper Coast and to help offset some of the risk and additional costs faced by start-up businesses. It does not apply to service charges or other council fees and charges such as planning fees.

Other sources of revenue for the Council are anticipated to be:

- User Charges and Commercial Revenue (\$2.827 million)
- Statutory Charges set by State Government (\$0.558 million)
- Grants (\$1.846 million)
- Other Revenue (\$0.403 million)

Project Priorities and Capital Expenditure

Proposed project priorities to be undertaken during the year ending 30 June 2018 are as follows:

• Continuous review of existing recurrent

- service levels provided to be undertaken in consultation with our community;
- Construction phase of the redevelopment of the Kadina Business District area as well as applying for further grants to assist with the project.
- Construction phase of the Copper Coast Sporting and Recreational Centre redevelopment.
- To finalise the design of Stage 2 of the new Wallaroo Swimming Enclosure.
- To complete the construction phase of the redevelopment of the Port Hughes Boat Ramp.
- Commence construction of the Kadina to Wallaroo cycle-ways.
- Complete the Moonta CBD Master plan.
- Facilitating the future financial sustainability of Council by ensuring the financial operations remain within policy targets adopted for such purpose;

- Continuation of Council's annual works program with a commitment to fund road reconstructions and reseals, footpaths, walking trails and foreshore developments;
- Continuation of the development of storm water management plans along with maintenance and renewal of storm water infrastructure.

All uncompleted projects and their funding allocation currently included in the 16/17 budget will continue and form part of the 17/18 works program.


Road Resealing Program

The 2017/18 year is a significant milestone for the community as the Council is now able to fully fund its road resealing program. This milestone has come through years of hard work, which included a reduction in operational costs, efficiencies and increased revenues. This means that roads can be maintained at the higher standard over the long term. However, while Council is also budgeting an additional \$2.3M to upgrade roads, residents should not expect an immediate change to all roads. This needs a long term commitment of funding over many years as well as time, equipment and resources to get the works undertaken. Council will soon release its updated Asset Management Plan that will include the full roads program. The graph highlights the significant increase in the resealing budget since it was introduced in 2013.


Footpath Program

The 2017/18 year is a progression of the community wide footpath program that was started following input from the community in to the 2012 Strategic Plan process. The program is expected to continue in future years and represents an investment equivalent to 5kms of new or upgraded footpaths per year.
