Section 41	No delegated financial authority. Reports to Council via the chair with recommendations for action
Section 43	Delegate/Deputy Delegate empowered to vote on behalf of the Council
Advisory to Council	The group has <b>no</b> decision making powers. Group provides a recommendation to the Council for consideration.
Advisory to CEO	The group has <b>no</b> decision making powers. If it is seen as though tasks are undertaken as a result of a discussion at a meeting, it is because the CEO has power to act within the financial capacity of a decision of Council, the ABP, Annual Budget and/or Council policy. The CEO is not directed by the meeting, but may utilise the meeting for gathering or disseminating information and/or as a sounding board for ideas.
Liaison Position	An Elected Member attends an external Committee and communicates back to the Council on that groups business. They are not a full voting member of the external group.
Local Government Association (LGA)	Delegate/Deputy Delegate empowered to vote on behalf of the Council
Appointment	This is a position appointed at the request of another organisation's constitution and they act independently of Council in the best interests of the external organization and are under no obligations to share information or make decisions in the best interest of Council.
