TERMS OF AGREEMENT

- 1. This agreement is for the sponsorship of a mini golf hole. Contributing to the Mini Golf Centre that will be a must see attraction for visitors as well as providing a quality family recreational facility for residents of the Copper Coast.
- 2. The sponsor agrees to the sponsorship of 1 mini golf hole of their choice with a sign and flag on the hole as promotion/advertisement.
- 3. It is agreed that the sponsorship is for a three year term from 1st July 2019 to 30th June 2022.
- 4. It is agreed that after the three years, a payment will be negotiated if the sponsor wishes to continue sponsoring the hole to retain the signage/advertising.
- 5. The Sponsor must pay the total Sponsorship fee of \$1,500 in payments of \$500.00 each year for three years.
- 6. The sponsor is the only sponsor for the chosen hole under the sponsorship agreement.
- 7. The Copper Coast Council will be responsible for the maintenance of the mini golf hole and its signage/materials.
- 8. The Council agrees to provide the sponsor with appropriate recognition in terms of signage containing the sponsor's Name and Logo.
- 9. The Copper Coast Council under this agreement is only allowed to use your logo on the mini golf when sponsoring. Sponsors remain the owner of all intellectual property rights regarding their logo.

- 10. If the nature of the purchased sponsorship package must be changed for any reason, the promoter agrees to notify the sponsor in writing.
- 11. The sponsorship package is not transferable for any reason. If the sponsor cannot meet the financial requirements of this agreement, the sponsor agrees to provide written notification to the promoter in a timely manner so that the promoter may find another suitable sponsor.

THE AGREED PUTT-PUTT SPONSORSHIP			
has agreed to sponsor hole number with the below sponsorship package: 1x Double sided ACP Sign, 42cm x 60cm portrait. That will display the sponsors logo in the centre with hole number at the top and difficulty along the bottom. The sign will be held by a black steel frame concreted next to the entrance of the chosen hole on the right hand side facing in a direction that the public can view from the road and grassed area.			
1x Flag 330mm x 200mm that will display the sponsor's logo in the centre on both sides and flag stick 76cm tall that will be placed on the chosen hole.
