REFLECTIONS

As we move into 2022 still dealing with restrictions due to the COVID-19 pandemic, it is the perfect time to reflect on the many COVID-safe events that were still organised throughout 2021. Despite the unpredictability of restrictions and cancellations, our community continued through the adversity and delivered fantastic events and celebrations which must be congratulated.

Our Australia Day celebrations at Wallaroo were a combination of the traditional Kadina Apex Club Australia Day breakfast and an array of entertainment provided by the Copper Coast Council, funded by a grant from the National Australia Day Council. The day was a celebration of all that we have to be proud of. We welcomed new Australian Citizens as citizenship ceremonies were performed and we celebrated the achievements of the many significant contributions to the Copper Coast. With this year's Australia Day event only a few days away, another memorable day is sure to be had.

The Copper Coast Council Events team partnered with local sporting organisations, volunteers and sponsors to host the largest SA Masters Games event in its 25-year history—1649 athletes competing in 28 sports. These games went on to be finalists in the SA Sports Awards as an event of the year and in my eyes, they were winners—unfortunately I wasn't a judge.

Again, we celebrated our Cornish heritage and history with the biennial Kernewek Lowender. Kernewek Lowender translates to "Cornish Happiness" and there was certainly plenty of that on display during this wonderful event. Despite the limiting restrictions, the hard-working Kernewek Lowender committee staged a wonderful event comprising of many traditional events we have come to expect as well as reinvigorating the festivities with some new events that I am sure will continue into the future.

NAIDOC Week was celebrated this year with a flag raising ceremony accompanied with a Welcome to Country and a smoking ceremony. It was a significant event in recognising the traditional custodians of our land, the Nharangga People. This year's theme "Heal Country" called for stronger measures to recognise, protect and maintain all aspects of Aboriginal and Torres Strait Islander culture and heritage.

It was an opportunity for all Australians to come together to celebrate the rich history, diverse cultures and achievements of Aboriginals and Torres Strait Islander people as the oldest continuing cultures on the planet.

We are supporting the call to unite to seek greater protection for our lands, waters, sacred sites and cultural heritage.

On the Copper Coast, the Nharangga people have much culture and heritage and we must (that is all of us together) play our part in recognising and protecting it.

The Kadina Show committee hosted their 150th successful show, which welcomed the now former Governor, His Excellency the Honourable Hue Van Lei AC and the Show was one of the most successful in recent times. Many new attractions were added and I am optimistic that this rural show and their dedicated committee will continue to flourish, enabling us to experience all that the show has to offer into the future.

The Yorke Peninsula Field Days were another resounding success thanks to the tireless work of the committee. This celebration of all things agriculture attracts many people to our community and I hope the community

continues to support and volunteer their time to help organise this great event.

We continued with the celebration of our heritage with the installation and unveiling of the Sir Richard Williams Sculpture. This Sculpture will ensure the Sir Richard Williams story will live on and the community should be congratulated in fundraising and organising a wonderful event to commemorate the occasion. We welcomed the Governor, Her Excellency the Honourable Frances Adamson AC and the involvement of the Royal Australian Air Force ensured the event was conducted with military precision.

There were many more events held throughout 2021, none less significant than the few I have mentioned, but unfortunately too many to acknowledge. These events are very important on the Copper Coast. All organising committees need to be congratulated for what they have achieved.

CEO's Update...

Many projects continue to be undertaken within the Copper Coast Council area. In the last newsletter, I highlighted many of these.

The Wallaroo to Moonta Cycling Walking Trail continues to be constructed and is a large project. With funding from the State Open Space, State Bicycle Fund, Council contribution and Council project management; the estimated cost is expected to be \$1.5 million.

The major upgrade of Bay Road continues to be progressed, with stormwater installation all but completed from the Bay end up to Highview Grove. Works have now commenced on kerbing where stormwater works have been completed and once the contractors have finished and moved to

between Robert and Haylock Street, the second contractor will begin to mobilise and reconstruct the road from the Bay towards the township, which is scheduled towards the end of February.

As mentioned in the last newsletter, we submitted two applications to the State Stormwater Management Authority for the funding of stormwater drainage at Moonta Road, Moonta Bay and George Street (Between Ellen and Henry Street, Moonta). I am pleased to advise that Council was successful with both applications. The State Stormwater Management Authority advised Council of funding of \$333,600 for the Moonta Road project, with Council contributing \$361,400 plus \$75,000 project management costs. We also received approval for \$180,000 for the George Street project, with Council contributing \$195,000 plus \$75,000 project management costs.

We have submitted an application to host the Australian Caravan Club Limited 2023 Caravan Muster in conjunction with the YP Field Days site and also the 2023 SA Masters Games. Following the receipt of submissions in relation to draft Cemetery Management

Plans for the four Council cemeteries, an Action Plan has been produced (with input from the Cemeteries Working Party). This will be considered by Council and the recommendations in the Plans implemented, so that our cemeteries continue to be repaired, preserved and developed.

We continue to progress a commercial outcome in relation to the previous Wallaroo Swimming Enclosure and will be lodging an application for funding for a new aquatic facility under the Federal Government's Building Better Regions Fund – Round 6. This application closes on 10th February 2022.

I would like to thank all of our Progress Associations, Clubs, sporting organisations and volunteers for the hard work and dedication throughout the year for many projects and services that have been undertaken and provided. It is only through working with you, that we can achieve so much for our community.

I trust and hope that all of you have a safe and happy Christmas and New Year, and I look forward to working with you all in 2022.

2022 COPPER COAST VISITORS' GUIDE

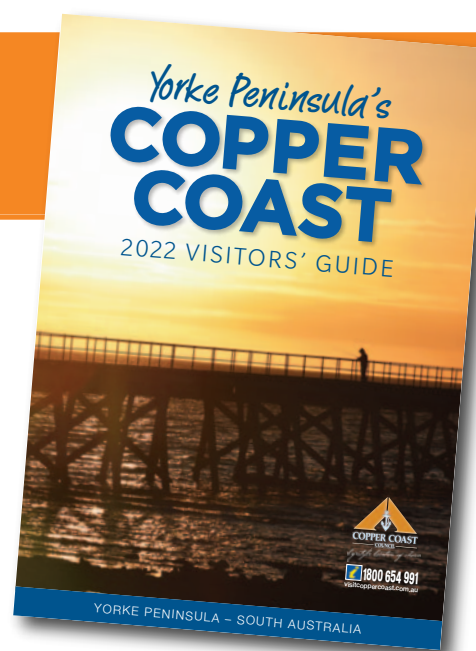

Bay Road Works R



Works have recommenced on Bay Road after the New Year break, with underground stormwater works along the mainline completed from Highview Grove towards the foreshore.

With sections of stormwater already completed between Milne and Frances Terrace, the remaining area is between Highview Grove and Kitto Road.

Kerbing preparation and laying has also commenced from the foreshore and the second contractor is set to begin mobilising and reconstructing the road from the end of February.

The western side of Bay Road has been complex due to collapsing sands and numerous underground services, requiring lengthy safety procedures to be implemented that slow down proceedings.

However, SA Water has been assisting by applying underground water connections for irrigating Bay Road median strips while these works are in progress, notifying residents in instances where water mains need to be temporarily shut down and offering alternative water solutions.

SA Power Networks' workers have been able to prepare for future proofing the undergrounding of powerlines, installing six conduit crossings between Hughes Avenue and Coast Road.

Contractors are also currently installing conduits between Coast Road and the foreshore.

We thank residents and visitors for their patience during these roadworks and are looking forward to having a beautiful, smooth road that leads to the stunning sight that is Moonta Bay.



WALLAROO TO MOONTA SHARED PATH

The approximate 14.9 kilometre shared path is coming along nicely, with the demolition earthworks and sub base preparation for the main section of the path nearing completion (Coota Road, Wallaroo to Wheal Hughes Mine, Moonta). This section will be spray sealed in the first quarter of this year.

Attention will then turn to the final stages within the town extents of both Moonta and Wallaroo, with community groups set to also be involved with items such as shelters, seating and other amenities.

The completion of this path is expected mid-year and will join up with the current Kadina to Wallaroo shared path, connecting the three largest urban towns in the Yorke Peninsula.

MOONTA CEMETERY WALLS UPDATE

Two walls repaired and one to go at the Moonta Cemetery, with works already underway on the Eastern Wall.

While some parts of the wall have structural issues that need addressing, the majority only requires minor chipping out and repointing works.

Contractors have done a fantastic job with the Eastern and Northern walls, sourcing local limestone to replace the deteriorated rocks along the outside and inside of both walls.

As part of the Cemetery Management Plans, there are a number of trees that need to be removed as they are encroaching on the cemetery walls and/or overburdening the area.

However, plans are in place to install vegetation at both the Kadina and Moonta cemetery to further compliment both areas.



MOONTA DOG PARK

The Copper Coast is soon to have its third dog park, with the Moonta Dog Park on the corner of Bay Road and Robert Street set to be open to all canines and their owners from late January/early February.

Works are nearing completion, with fencing, air lock entry/exit gates and dog play equipment all installed.

Now all we've got to do is wait for the grass to grow, install signage and tidy up the surrounding area in preparation for the opening, with the dog park seeded for lawn last month.

The park is set to have a more natural look to tie in with Polgreen Park across the road, but will still have all the essentials you and your pup will need like the Kadina and Wallaroo Dog Parks.



BEAUTIFICATION OF WALLAROO

The reserve corner of John Terrace and Jetty Road certainly looks more inviting, with greener pastures and a new shelter.

Now you can enjoy a sausage sizzle on either side of Jetty Road, with the shelter featuring a BBQ, concrete floor, tables and seats installed across from the Weeroona Hotel.

The area now also contains retaining walls, garden beds, improved irrigation and has been reseeded, making it greener and more welcoming for families during the summer period.

This project will be completed once new trees are planted and it's another step in the continued beautification of Wallaroo's open spaces.

ELLEN ST MURAL

The Ellen Street Carpark in Moonta looks a lot more colourful thanks to the beautiful mural created by local artist Julie Cheshire.

The artwork depicting the beautiful sites of the town ties in nicely with the new garden and upgraded toilet facility.

This is the second masterpiece mural Julie has created after her work on the Wallaroo Heritage Mural across the face of the old Wallaroo Railway Station platform.

Thank you Julie, and we hope residents and tourists enjoy the amazing artwork.



CINEMA RETURN

The Kadina Cinema is back in operation, with new Lessees and current Cinema Augusta operators Michelle and Roger Coles taking over.

The grand reopening was at 7pm on Thursday, 9 December 2021 with the new family movie *A Boy Called Christmas*, where many locals attended to support the new venture.

Council is also working with the new Lessees on reopening the Moonta Cinemas in 2022 following the repair and upgrade of the Moonta Town Hall.

We thank previous Lessees Carol Burford and her husband, the late David Burford, at Statewide Cinema for their passion and contribution over the last 14 years to keeping cinema alive on the Copper Coast.

Council has worked with Carol to purchase the existing Cinema equipment for both Kadina and Moonta for the new Lessees.

LONGER SPLASH TOWN HOURS

The new lease and Splash Town Management Agreement between Council and the Moonta Bay Holiday Park was signed, sealed and delivered in November, enabling flexibility to the times and days the water park is open.

The Moonta Bay Holiday Park is

now responsible for the opening and closing of Splash Town, and water testing—allowing Council staff to focus on other community services.

The Holiday Park's near proximity to Splash Town and operating hours means the facility can be open everyday from 11am to 6pm, until the end of the April School Holidays (1 May 2022).

In a further boost for residents and tourists, the Moonta Bay Holiday Park may also extend the hours of Splash Town on hot weather days—except when closed due to inclement weather or unplanned maintenance, which will be advertised on the Moonta Bay Holiday Park and Splash Town - Copper Coast Facebook pages in advance.

We thank the Moonta Bay Holiday Park in helping to increase the operating hours of this tourist attraction and hope to see more families heading to the Moonta Bay Foreshore.

Financial Summary

The table right is a summary of the audited financial results of Council for the past two years and the adopted budget for 2021-22.

Council reported an operating surplus (before capital adjustments) of \$3,918,309 compared with an original budgeted deficit of \$377,829. The operating surplus was primarily due to a rise in caravan park earnings to \$2,882,058, an increase of approximately \$1,000,000 amid COVID-19 border restrictions as well as the advance payment of the financial assistance grant of \$1,117,688, which is recognised in Grants, subsidies and contributions.

The Commonwealth Government during June 2021 forwarded to Councils their funding under the Financial Assistance Grants Scheme 50% of their 2021/22 allocation.

Other income also includes an amount reported as \$624,617 for the reduction in the landfill provision. Under the current accounting standards, this income is to be reported in the year of receipt and therefore inflates the net position in 2020/21 and therefore also 2021/22.

Employee expenditure also decreased against budget during 2020/21 due to the COVID-19 closures of some of Council activities and the reduction in the use of casual staff and overtime payments.

Council received grant funding in advance for the walking and cycling trail between Moonta and Wallaroo of \$418,000. This project had commenced and is due to be completed by the end of 2022.

Where do the funds come from?

Council receives some funding in grants from other Governments and raise some funds in user fees and charges, however, approximately 71% of revenue came from the Council Rates in 2020-21.

The pie chart (right) outlines the areas in which Councils receive funds in a typical year.

How is the money spent?

Council provides many services to the community, some of which are legislated and others which are provided by choice. Many of our services are largely invisible (ie stormwater management,

community wastewater management schemes), but are definitely a necessary service provision.

Council's expenses represent the cost of providing these service to the community. Materials, contracts and other expenses made up 42% of the total operating expenditure of Council. Council Employees are its most valuable asset and provide the numerous services listed for the community at a consistent operating cost of 24% of expenditure. Depreciation makes up 30% of the total operating expenditure.

Whether a service is a legislative requirement of Councils, or is provided by local choice, the Local Government Act requires that a Council is "responsive to the needs, interests and aspirations of individuals and groups within its community..." and that it must "...seek to ensure that Council resources are used fairly..." (Section 8, (b) and (h)).

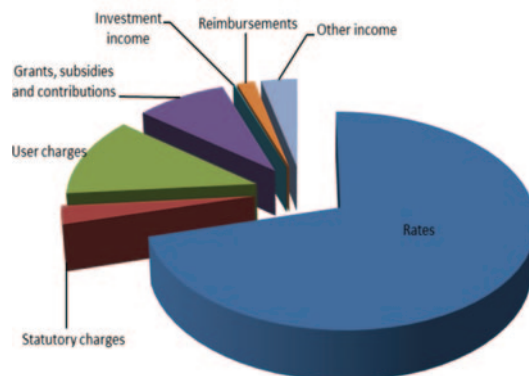
What assets does Council own?

When looking at the Council Balance Sheet, the Council assets totalled \$307 million. This includes money that is owed to Council in the form of Rates and other services (Trade & other receivables), stock on hand (inventories) and for the large proportion Trade & Other Receivables (Rates – General & Other) is quite large as a result of the outstanding separate rate applied for the Wallaroo Shores Development, which includes the outstanding interest. This was a six year agreement which expires on 30 June 2023.

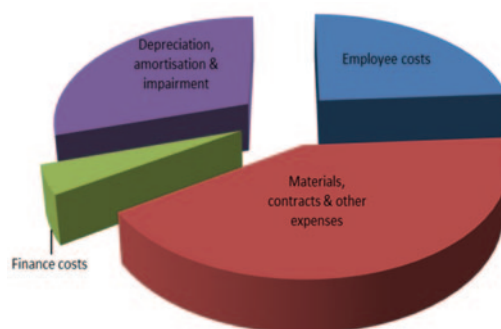
Infrastructure, Property, Plant & Equipment make up Council's non current assets. There were no revaluation of fixed assets, being the land, buildings and other infrastructure conducted during 2020/21. The revaluation decrement of \$316,317 was a prior year adjustment of land and this is reported in the Statement of Comprehensive Income as Other Comprehensive Income in 2020/21. Additions to these assets from this date have been measured at cost. One of the challenges facing Local Government today is finding the revenue required to maintain the large amount of community infrastructure under its care and control.

What liabilities does Council owe?

Council's liabilities include loans, amounts owing to suppliers, amounts owing to employees for leave entitlements and amounts owing to residents of our retirement villages should they no longer occupy one of our units in Moonta or Wallaroo. Council's borrowings are reported in

the Annual Report and also in the Annual Financial Statements. Each budget review, a table reporting these borrowings and the associated balance is also provided.

The balance is currently \$29.51 million as at 30 June 2021, however, it is important to note that this also includes \$4.0 million for the retirement village licences in Moonta and Wallaroo.



2021/2022 COMMUNITY GRANTS

Congratulations to the 35 non-profit and community groups who received \$95,319.56 in Council's 2021/2022 Community Grants this year.

We are thrilled to be able to fund so many beneficial projects and activities that

will improve the community.

Mayor Roslyn Talbot, Chief Executive Officer Russell Peate and Director of Corporate and Community Services Katrina Borlace were on hand to present this year's grants in the

Kadina Town Hall on 13 October, 2021.

A special thanks to our Council staff, who helped treat the Grant recipients to a sausage sizzle and beverage following the presentation.

Starclub Updates

COVID-19 has affected many sporting clubs through reduction in participation and/or finances. However, some clubs have been able to adapt, connect and advertise with their members and sponsors through modern forms of communications such as social media, webinars and live streaming. With lockdowns and restrictions these past couple of years and the unpredictability of the future, sporting clubs need to be evolving with the times if they are to survive on their own.

At the 2021 Club Development Conference organised by the Office for Recreation, Sport and Racing (ORSR), keynote speaker and international tennis coach Roger Rasheed spoke of how communication for all sectors is massively important and we need to learn how to communicate with each other.

Sporting clubs provide a fountain of knowledge about a community and what's happening in a region through its social aspects. For many members, a club is like a family because of the mateships created and trust built. The environment also gives youth leadership, commitment and engagement. But sometimes youth, like the

child of a family, can be left unheard by the experienced heads of a club.

In these times where members and sponsors are being lost due to a lack of face-to-face contact and reduction in games/matches, why not give the youth of your club some responsibility by helping your club engage with the modern forms of communications and attracting interest in the club.

Struggling for volunteers? Give them rewards for their efforts! Offer them further training that will not only benefit your club, but their own lives outside of the club. Give them club vouchers for their time that they can spend at the canteen. Make well-known volunteers ambassadors of the club, publicise their stories and make them role models to encourage other members to follow in their footsteps.

Need more finances? Hire out your

facilities for community events or host your own social/fundraising events to build better connection among members – it might even make other community members envious of the fun and facilities on offer at your club and encourage them to join.

Sporting hubs or precincts are the future. Sporting groups getting together to help each other and share facilities and sponsors is clever business. A club struggling should look at one of the bigger clubs and join forces. It's better to survive in a joint venture than becoming insolvent on your own.
