After so many months of planning, the members of the Pony Club's carried a message from me as Mayor to the then Lord Mayor of the City of Adelaide. Congratulations to the members and riders of the local Pony Clubs with their Symbolic Horse Ride.

with the Ride and now being ever confident in our future when we recognise two young Citizens.

When selecting a recipient for this award we could not separate two wonderful young people. Rats/Mice Prevention and Control

As in past years the Copper Coast is at risk of plagues of rats and mice.

Rats and mice are not fussy eaters and can make themselves at home in houses, sheds, garages and gardens. They are not only smelly and destructive, but can pose risk to human health.

Why the concern?

Rats and mice can:

- Transmit Diseases such as leptospirosis, typhus fever and rat/ mice bite fever
- Contaminate food with their hair, droppings and urine resulting in poisoning and wastage
- Generate unpleasant odours
- Carry fleas or ticks which can harm pets or humans.

Rats/Mice are destructive and can cause damage with their gnawing and digging. They can damage materials such as food containers, wood, particle board, insulation and wiring (gnawing of electrical wires may cause fires).

Avoiding rat and mice problems

Rats and mice are well adapted to living in human environments. To reduce the number of rats and mice on your property:

- Ensure rubbish bins have tight fitting lids and are regularly emptied
- Keep your home and property clear of rubbish
- Keep stacked materials such as wood at least 30cm above the ground to minimize hiding/nesting/thoroughfare of rats and mice.
- Regularly clean out sheds, storage areas and dispose of unwanted items
- Remove unwanted undergrowth cut back grass, trees, bushes, and creepers which may provide cover or access to the roof
- Dispose of fallen fruit, seed and waste from aviaries and chicken pens and pet faeces

- Do not use open compost heaps
- Do not compost any animal products (fish, meat, chicken, cheese, butter) or pet faeces
- Leave out just enough pet food for pets to eat
- Store poultry food in vermin proof containers with close-fitting lids
- Block access points to cupboards containing food and food preparation utensils
- Inspect and repair any cracks, crevices or holes in buildings and sheds with concrete, hard setting filler, steel wool or heavy gauge sheet metal
- Cover rainwater tank openings and floor vents with wire mesh no coarser than 1mm and check and maintain these regularly.

Protecting yourself

If rats and mice are present:

- Secure all foodstuffs in sealed containers
- Throw away food or drink that may have come in contact with rats or mice
- Wash cookware and cutlery in warm water and detergent before use
- Wash hands thoroughly before preparing food, eating or drinking
- Wear shoes and don't lie/sleep on the floor/ground,

If you are bitten by a rat or a mouse, consult your doctor promptly.

Chemical Control

- Chemical control is generally short term and rats and mice will return if food and shelter are still available.
- Rat and mice poisons or rodenticides containing an anti-coagulant can be purchased from hardware stores or supermarkets.
- Extreme care must be taken when using poisons (read instructions carefully) to prevent the danger of

- children or pets being accidently poisoned.
- Rat and mouse baits should be placed in locations away from open spaces.

Chemical control for some situations may not be appropriate.

Some disadvantages of poisoning rats and mice need to be considered:

- If rats and mice die and decay in hard to reach places they may cause an odour
- The risk of pets eating toxic baits or poisoned vermin bodies
- Individuals allergic reactions to rat and mice control chemicals in their environment.

Trapping may be more appropriate in some situations.

Trapping

Several traps should be used at one time. Traps can be purchased from hardware stores or supermarkets.

Traps can be successfully set with bacon, peanut butter, fish, meat, bread or chocolate.

Disposal of dead rats and mice

Dead vermin can be buried or wrapped and placed into domestic rubbish bin. Gloves should be worn where possible when handling rats and mice.

Remember to wash your hands with warm water and soap immediately after handling rats and mice.

A collection of citations of pioneers featured in the popular 'Dressing the Graves' event is available, as is a comprehensive collection of local pioneer family histories.

Our draft Annual Business Plan and Budget are now open for public consultation and we invite community feedback to help shape the services we provide now and in the future.


Strategic Plan - Moving Towards 2020

Significant Influences and Priorities

A number of significant factors have influenced the preparation of the Council's 2011/12 Business Plan and Budget. These include:

- Local Government Price Index increases on relevant goods and services currently at 30.4 % for the December 2010 quarter
- Current Enterprise Bargaining Agreements for staff which provide for wages and salary increases in line with current and proposed wage agreements
- Requirements to maintain and improve infrastructure assets to acceptable standards including parks, reserves, town and rural roads, footpaths, lighting and community facilities.
- Service and infrastructure needs for a growing population which exceeds the states average population growth

• Commitments to major projects and partnership initiatives over more than one year, including Wallaroo Foreshore Development, Elder Friendly Community, Community Transport Scheme and CWMS.


In addition, substantial external influences are also expected to impact the local government sector and the Copper Coast over the next year. The implications for this Council potentially include:

- Increased development activity in a coastal environment impacting Council's ability to implement adequate infrastructure and services to keep pace with development and demands of new residents.
- Reduced discretionary spending which will impact on Council's ability to build new roads.
- Reduced housing affordability putting pressure on Council to provide an affordable housing alternative.


- Increased opportunity for new business to enter the region
- Pressure on Council to undertake significant facility and infrastructure upgrade
- Increased requirements to provide access to sporting and recreation facilities to the broader community
- Increased demand to maintain heritage and improve cultural facilities in partnership with stakeholders

Rates and other income

Rate revenue enables Council to develop and to deliver many of the services offered to the community. Rates, which form approx 64% of Council's total revenue, are supplemented by State and Federal grants and user fees and charges. Council also undertakes commercial activities and invests funds to increase total revenue.

Continuing Services

Council has a responsibility under the Local Government Act and other relevant legislation. These include:

- Regulatory activities e.g. maintaining the voters role and supporting elected members
- Management of basic infrastructure including roads, footpaths, parks, public open space, street lighting and stormwater drainage
- Street cleaning and rubbish collection
- Development planning and control, including building safety assessment
- A range of environmental health services.

Other services provided in response to community needs include:

- Street trees
- Environmental plans and projects
- Public health and safety (including dog/cat and parking management)
- Community and cultural development
- Youth development
- Community and sporting facilities
- Library service
- Tourism
- Aged services

Cycling and Walking Strategy

The District Council of the Copper Coast is grappling seriously with Australian's love of their private motor vehicle. This is one battle we must win if we are to avoid congested roads and subsequent pollution that dominates some urban centres.

Council believes that together we can protect the magnificent Copper Coast lifestyle and the *Cycling and Walking Strategy* is an important step towards this goal. The Copper Coast with its outstanding scenery, farmland, bushland, coastal vegetation, country towns and scenic roads and trails network is an ideal setting for development of tourist and recreational activities based on long distance walking, cycling and off-road cycling.

More recently however, we have come to recognize that walking and cycling must penetrate the mainstream of future transport solutions. It is recognized that we must achieve a 10% shift of trips from private motor vehicle to alternatives including public transport, cycling and walking.

The recently adopted Cycling and Walking Strategy available on Council's website, includes some of the key issues and the need for change towards a walking and cycling friendly environment. Council's strategic plan identifies ongoing commitments for this strategy and has recently met with various community groups as well as government to formulate a project plan that will enable a coordinated approach to moving the strategy forward.

This project will include consideration of the needs of the various users including school children, sports groups, commuters, recreational users and tourists giving special consideration for the disabled, elderly, parents with prams, rollerbladers and skateboarders. While a number of the groups have similar requirements, it is often necessary to provide facilities for more than one group in any one corridor.

The first step in the project is to map existing trails, identify gaps and undertake analysis of community need. Community groups have shown a keen interest in being involved in creating a network of walking and cycling trails.

Watch this space for the future of cycling and walking on the Copper Coast

Retirement Units

The District Council of the Copper Coast currently owns and maintains 36 retirement units being, 14 at Wallaroo, 12 at Moonta and 10 at McCauley Homes, also in Moonta. The opportunity exists for this number to be increased to 57 in total should the demand be demonstrated.

Prospective occupiers are required to lodge an "Expression of Interest", which is available from Council, to have their names entered on the waiting list. Those who can demonstrate special needs, through an assessment process, may progress their applications more quickly.

There is no cost associated with the lodgment of the "Expression of Interest" and two or 3 bedroom units are available as either stand alone or as dual attached.

When a unit becomes available, the applicant is invited to inspect with Council staff to ascertain their interest and discussion held on the price of the "License to Occupy".

Once both parties agree, the applicant is given a minimum of 3 months to sell their existing home (if necessary) to purchase the "License to Occupy". There is no GST or Stamp Duty costs in the transaction. Once the new occupant takes over the unit, their financial responsibilities are contents insurance, telephone, power and a weekly maintenance payment to Council, which covers gardening, Council rates, water rates and building maintenance. This weekly maintenance fee is currently \$45, and is reviewed annually.

When the time comes for the occupant to vacate the unit, the occupier, or their estate, receives a payment based on their term of occupancy of the unit.

If they leave the unit with the first year, the amount refundable is 90% of the amount the license is resold for, less expenses. Between 12 and 24 months it is 85% and between 24 and 36 months it is 80%. After 36 months it is 75% of the amount the license is resold for, less expenses, and remains at that level.

Annual meetings of occupiers and Council staff are held to discuss finances and any other matters of concern.

Rainwater Tanks—What you should know?

Council's Rainwater Tank Policy (which was adopted by Council in January 2008) was reviewed and the amended Policy adopted at the Council Meeting held on 6 April 2011.

Background

The original Policy prescribed minimum capacity for water tanks for all new residential dwellings based on the allotment size. In terms of the old Policy the following minimum capacity rainwater tanks applied to the land area of allotments:

- Allotments with an area less than 449m² – 5,000 litres or greater.
- Allotments with an area 450m² to 649m² 10,000 litres or greater.
- Allotments with an area more than $650\text{m}^2 22,000$ litres or greater.

The Policy affected new residential dwellings only and was silent about any requirement to provide rainwater tanks for commercial and industrial developments.

Reviewed Policy

The reviewed Policy includes the requirement to provide rainwater tanks for all new commercial and industrial development in addition to new residential development as follows:

Dwellings

- (a) Five thousand litres in areas prone to bushfire, plus whichever applies in (b) or (c) below.
- (b) Sixty thousand litres in areas where no reticulated water supply is available; or
- (c) In areas where there is a reticulated supply available
 - Five thousand litres or greater on allotments less than 450m² in area; or
 - Ten thousand litres or greater on allotments with an area of 450m² to 649m²; or
 - Twenty-two thousand litres or greater on allotments with an area of 650m² or greater.

Commercial and Industrial Development

- (a) Five thousand litres in areas prone to bushfire, plus whichever applies in (b) or (c) below.
- (b) Sixty thousand litres in areas where no reticulated water supply is available; or
- (c) In areas where there is a reticulated supply available
 - Ten thousand litres or greater on allotments with an area less than 1,000m²; or
 - Twenty-two thousand litres or greater on allotments with an area of 1,000m² or greater.

All rainwater tanks associated with new residential, commercial or industrial developments should be.

- (a) coloured to be in keeping with buildings and required landscaping,
- (b) adequately screened from the property's road frontage and/or water frontage,
- (c) set back at least 0.6 metres from a rear and side boundary for maintenance purposes, and
- (d) connected to an irrigation system to irrigate required landscaping where associated with more than one dwelling unit or commercial or industrial developments.

Council Approval

In terms of the Development Regulations 2008 installation of a rainwater tank (and any supporting structure) is defined as "development" requiring Council approval if the answer to <u>any</u> of questions (1) to (4) below is "no":

- (1) Is it part of a roof-drainage system?
- (2) Is the floor area 10m2 or less?
- (3) Is it located wholly above ground?
- (4) Are all parts 4m or less above the natural surface of the ground?

If the answer to any of questions (1) to (4) is "no", an application needs to be lodged with Council. However, Building

Rules Consent only is required before Development Approval can be granted if the answer to <u>all</u> of the following questions is "yes":


- (1) Is it part of a roof-drainage system?
- (2) Is the floor area 15m2 or less?
- (3) Is it located wholly above ground?
- (4) Are all parts 4m or less above the natural surface of the ground?
- (5) Are all parts located behind the building line of the building to which it is ancillary that faces the primary street?
- (6) In the case of metal is the tank pre-colour treated or painted in a non-reflective colour?

If the answer to any of questions (1) to (6) is "no", Development Plan Consent as well as Building Rules Consent is required before Development Approval can be granted. Underground rainwater tanks (and any associated pump) require Building Rules Consent only if:

- the tank is ancillary to a dwelling erected on the site; and
- the tank (and any associated pump) is located wholly below the level of the ground.

Where rainwater tanks (above ground or below ground) are proposed as part of a new development, whether it is residential, commercial or industrial, it can be approved as part of the new development and will not require separate approval.

If you are uncertain whether any approval is required, please contact Council's Environmental Services Department.



Changes at the Helm!

Geoff said, "In the short time that I have been with Council I have realised that the Copper Coast Region is truly a dynamic and exciting region with enormous growth potential along with the challenges that accompany this growth. I have enjoyed the welcome and support from the Mayor, elected members and staff of the Council as well as the hospitality of the community. I am looking forward to participating in the Kernewek Lowender festival and the Cornish Pasty Workshop so that I can learn the recipe and how to crimp a pasty".

McArthur Consulting have been appointed to assist the Elected Members recruit a new Chief Executive Officer, which is anticipated to be taken up by the beginning of June. We are confident that a well motivated skipper is looking to make a sea change and take the helm!

Cornish Pasty Name Safe In Copper Coast

On February 22, the European Commission awarded the Cornish pasty "protected geographical indication" status, meaning only Pasties made in Cornwall and following the traditional recipe can now be called a "Cornish Pasty".

Copper Coast residents and the Kernewek Lowender Committee initially saw this as a major blow to the Copper Coast and a threat to the areas identity as 'Australia's Little Cornwall'

However after further research and communication with the Cornish Pasty Association in Cornwall it was discovered that the ruling by the European Commission can not be enforced in Australia.

The naming right ruling which was made by the European Commission can only be enforced in countries who are a member of the EU. Meaning the Copper Coast can continue using the 'Cornish Pasty' name and will do so proudly.

As a result of this hot topic and the nation wide publicity received the Kernewek Lowender Committee is now expecting the Cornish Pasty Workshops held as part of the Festival in May to be sell out events. The workshops provide participants with the opportunity to learn the traditional Cornish pasty recipe and how to crimp the pastry.
