

Mayor's Message...

Reduce, Reuse and Recycle

Waste reduction and recycling is a topic that seems to be a priority for many. We here at the Copper Coast Council are no exception.

We have been working hard to reduce the amount of waste we produce, and to have affordable options for Ratepayers to dispose of their waste.

Many initiatives are in place and as the funding becomes available, further initiatives will be introduced for our communities benefit.

Increasing emphasis has been placed onto the cost of waste disposal, reducing the cost and making it affordable. One tier of Government even views waste as a method of raising revenue by imposing a levy, a tax, on the waste that is disposed of. The burden of this levy is carried by everyone, we all have some waste to dispose of.

It took a moving conversation with two young girls to remind me the real reason behind reducing waste, and the need for better recycling. We sometimes get so wound up in fiscal benefits, we forget the raw message these two young girls deliver so passionately.

Their focus was not on the cost of waste; their primary objective was saving the environment. They eloquently explained to me the harm plastic straws have on our environment, the animal lives that are negatively impacted by careless disposal of soft plastics, and how refraining from using single use plastics could make a collective difference. They wanted our precious environment protected so that they, and the generations of the future could enjoy its beauty.

There are many ways we can all reduce, reuse and recycle to minimize the amount of waste that is sent to landfill, a disposal method that ultimately has a negative impact on our environment. It is far too easy to think that my little bit of rubbish will not make a difference, but it does. I have still only been here for just over four months and much has been progressed and undertaken. The Council has been working in partnership with the Department of Planning and Infrastructure for the reconstruction of Mines Road and I am sure this will be a great outcome when it is completed. We have undertaken initial consultation on the Bay Road upgrade. 76 submissions were received which was very much appreciated. There are a number of very good suggestions which we will now consider to incorporate into the detailed design of this road. We will then discuss this with the residents that live on Bay Road regarding this detailed design to obtain their views. It is important to spend time discussing the detailed design for the road with residents that are affected.

The Kernewek Lowender Festival was a fantastic community event. I have been to many festivals and events in two States and have never seen the level of community involvement (from the Schools, Businesses and Community) that exists with the Kernewek Lowender Festival. Well done to all involved.

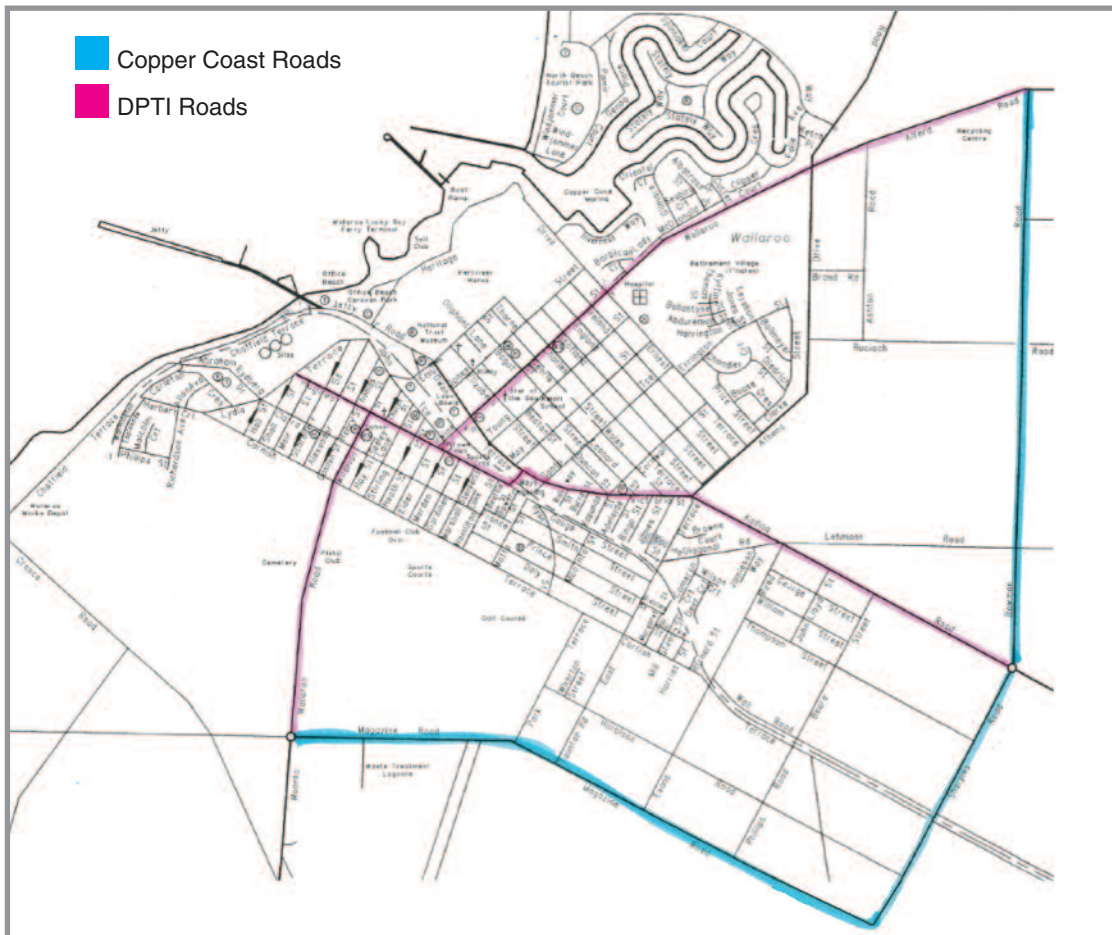
We have submitted an application for funding for the repair of the Wallaroo Break Water and expect to be advised in the next few months. If we receive the funding, it is planned for the repair works to be finished before Christmas. The Kadina Town Hall has been repaired and upgraded at a cost of \$1M. The Mayor hosted a morning tea for volunteers to officially open the refurbished Town Hall and also to recognise the great contribution our volunteers make to our

communities. My appreciation goes to the Director of Infrastructure Services Wade Della Torre, Project Team Leader Tim Neumann, the Contractor and all of those involved.

We have been approved to receive \$1M under the Federal Drought Communities Program Extension and for this we are very appreciative. We are in the process of identifying projects that meet the criteria and these will then be submitted to the Federal Government for approval. We have received funding from the Federal Government for a Conservation Management Plan for the Moonta Mines Precinct. The Moonta Mines Precinct received National Heritage Listing last year. The Conservation Management Plan will guide what further developments can be done in this precinct.

ROAD SWAP

We have submitted an application for the Wallaroo entrance road to be swapped, (please see map left) with the Department for Planning and Infrastructure. We are doing all we can to progress this road swap, so that the Wallaroo entrance road can then be reconstructed and upgraded. We are in the process of obtaining the Crown Land opposite the parts of Jetty Road and Chatfield Terrace from Wildman Street through Abraham Rydberg Drive, so that this land can then be upgraded and beautified for Wallaroo, but also when the first Cruise Ship arrives on the 7th December this year.

Does my Dog Need to be on a Lead?

As per the Dog and Cat Management Act 1995, you are required to have your dog on a leash of no more than two (2) metres length in all public places, in private places where you do not have the consent of the occupier.

If your dog is off-leash you must have effective control, this means being recalled by voice command. Please check our website for locations within the Copper Coast that dogs are allowed to be off-leash.

Council has a current Animal Management Plan which also shows designated on-leash areas and off-leash areas, check out our website (www.coppercoast.sa.gov.au) under animal control for these locations.

Dogs are prohibited from all children's playgrounds within the Copper Coast.

All dogs must be registered and microchipped. Registrations are now due.

What You May Not Know About Your Library

Libraries are free! Copper Coast Libraries are located at Kadina, Moonta and Wallaroo.

Childrens Programs: programs for babies, toddlers, pre-schoolers and school holiday activities.

JP Services: JPs are available at the Moonta Library every Tuesday afternoon from 3pm to 3.30pm and the Kadina Library every Wednesday afternoon from 1pm to 2.30pm. No appointment necessary.

Home Delivery: a service is offered to Copper Coast housebound residents who are physically unable to visit the library.

eCollections: you no longer have to physically visit the library to access resources. Simply visit the library online catalogue and follow the links to download eBooks and eMagazines to any digital device.

Toy Library: is located at the Kadina Library. It has an extensive range of toys and puzzles to cater for the early learning and play needs of preschool children.

Public PC's: access to the internet, Microsoft Office and more, printing and photocopying is also available.

Free Wi-Fi access: allows anyone to bring their own laptop, tablet or mobile device

(fitted with wireless capability) to the library and get free internet access on that device

Mobile Printing: available at the Kadina Library this service allows you to use your personal computer or mobile device to print to the library's printer from anywhere. Simply submit documents for printing and come to the library to release and pick up your document using your library card.

Book Clubs: run from all Copper Coast Libraries.

TaxHelp: This free service for low income earners is provided from July to October each year at the Kadina Library to assist people to submit their Tax Returns online. Appointments required ph. 88210444.

One Card: Your library membership card gives you access to over 4 million items. Either reserve items to be collected from your local library or use your card when you visit any public library in South Australia.

Libraries SA App: a free app that gives you quick and easy access from your mobile device to digitally store your library card, place holds and access your library account.

Working With Children Checks, Everyone who volunteers or works with children must have a valid child-related check, by law, from 1 July 2019. It's about helping to create a safer environment for them. If you have a current national police check, it will be valid until 1 July 2020. A

current child-related clearance will remain valid until it expires. Then you must have a new working with children check. If the check's just for volunteering, it's free. For more information check the Human Services SA Website.

Sports Vouchers – 169 Sports Vouchers have been claimed in the Copper Coast Council area this year. Great to see Krank It Dance making the most of the program which now allows dance sports to be eligible for the \$100 discount to subscription fees. Fences

Council receives many enquiries on the rules and regulations for erecting a new fence. Residents can obtain a booklet from Council titled 'Fences and the Law'. This is a general guide for residents on how to go about erecting a new fence and provides various forms to send to adjoining land owners.



Fencing is an Exempt form of development (i.e. no assessment or approval required) except for the following conditions;

- swimming pool safety fence (special requirements apply)
- a masonry fence higher than 1 metre,
- any kind of fence higher than 2.1 metres,
- a fence over 1 metre in height within 6 metres of a road intersection (except where a 4 x 4 metre corner cut off has been provided).

- A Brush Fence closer than 3m to an existing building unless the building is fire rated.
- Any type of fencing in
 - State Heritage Places or Areas
 - Local Heritage Places
 - Historic (conservation) Zones or Policy Areas

Councils Annual Free Tree Day



As part of the Copper Coast's "Green Up" initiative, on the 26th of May, 2000 Trees were distributed (Kadina 680, Wallaroo 660, Moonta 660) at the three townships Town Halls. The trees are sourced locally through NYP Plant Society and the balance sourced externally. All remaining plants are used in partnership with our community groups.

Disability Discrimination Act Advisory Group

The DDA advisory group is working actively through the Local Government Association (LGA), providing input into the State Disability Inclusion Plan (SDIP). The advisory group has provided written recommendations as well as participating in workshops. The DDA advisory group will continue to advocate the needs of our community through the State plan to ensure our local plan is developed in partnership with the State initiatives. A draft SDIP is scheduled to be available in October 2019.

Councils current DAIP, the Disability Discrimination Act Access and Inclusion Action Plan 2014-2019, was adopted by Council on the 5th of March 2014. Under legislation Council is required to review its own Disability and Inclusion Plan (DAIP) and will be doing so in conjunction with neighbouring Councils. The DDA Advisory Group will seek input from its community through a variety of forums; social and local media, newsletter (questionnaire), in developing our local DAIP and to ensure it is supported by the State Plan and is consistent with our neighbouring communities.

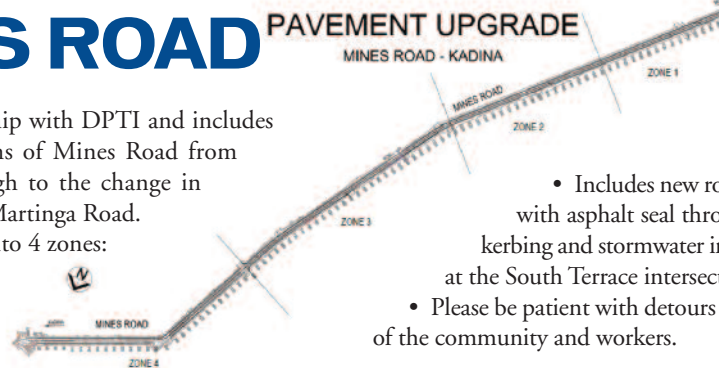
Kadina Cemetery Walls

Annual Business Plan & Budget Summary 2019/20

The Annual Business plan sets out the Council's proposed services, programs and projects for 2019/20. It aims to maintain a variety of services and facilities for the community and continue progress toward the longer term objectives for the Council area as set out in the Strategic Management Plan adopted by the Council.

Specific objectives for the year are proposed consistent with the Council's Long Term Financial Plan and Asset Management Plans to ensure the long term sustainability of the Council's financial performance and position.

Councils' primary sources of income are rate income and grant revenue. The following table provides a summary of the Budgeted Operating Income and Expenditure for the 2019/20 year.

The result being an operating deficit of \$893,915 before capital grants and estimated income from asset sales.



Significant Influences and Priorities

A number of significant factors have influenced the preparation of the Council's 2019/20 Business Plan and Budget. These include:

- An operating deficit budget in the short term and working to reduce this consistent with the Long Term Financial Plan
- The Local Government Price Index of 2.7% as at December 2018 quarter
- Adelaide All Groups CPI of 1.6% as at December 2018 quarter
- Enterprise Bargaining Agreement wage increases
- Known decreases or minimal increases in revenue sources from the Federal & State Governments

- Increases in levies imposed by other tiers of Government including NRM levy and EPA Waste Levy
- Service delivery & infrastructure needs for a growing population
- The need to address the issue of financial sustainability and asset renewal including roads, footpaths, CWMS, Council properties and stormwater drainage with more funding for infrastructure renewal
- To investigate and deliver changes to Waste Services where budgets allow

In response to these factors, and to minimise the burden on rate payers, the Annual Business Plan has been prepared within the following guidelines:

- The Annual Business Plan will result in the total revenue raised through general rates increasing by approximately 3.2% plus revenue from newly developed properties.
- Total operating expenses to be held where possible, within levels of the previous financial years and adjusted by the Local Government Price Index allowing above indexation increases to be allocated directly to maintaining community assets, such as stormwater infrastructure, roads and footpaths.
- A year to consolidate on the previous capital intensive budgets and review the strategic direction of Council.



What it means for Rates in 2019/20

Rates Revenue

Comparing rates between Councils is difficult. Every Council has different attributes and provides varying services or similar services at different standards. Councils deliver an extensive range and levels of service to the community with the greater part determined by the expectations of our communities. The price of delivering and providing these services is spread across the community in the form of rates. Council determines a rate in the dollar, based on the amount of revenue that will be required to meet the ongoing cost of providing services to our community for the coming year. Council's revenue for 2019/20 includes an estimated \$17.5 million from general rates.

Council has increased the differential rate in the dollar by 3.2%. The actual increase payable by any individual ratepayer may be more or less than this, depending on the movement in the capital value of each property.

The fixed charge has increased from \$588 to \$607 which is a 3.2% increase.

Separate Rates

Port Hughes Golf Course (Dunes)

The Council introduced in 2013/14 a separate rate to partly fund the maintenance of the Port Hughes Golf Course (Dunes) which replaced the existing annual development levy that each land owner agreed to pay to the developer of The Dunes Port Hughes. This will continue at \$721 per property.

Kadina CBD

The local traders in the Kadina business district requested a separate rate to fund \$30,000 of planning/marketing towards development in this area. This rate will continue under a new name and varied purpose and these funds will be transferred to the Kadina Chamber of Commerce who will administer them.

Riley Cove Community Corporation

During 2014/15 residents of the Riley Cove Community Corporation approached Council to adopt a separate rate to fund the internal road maintenance at the Riley Cove Village. This rate (\$265) will continue for a period of 100 years and reviewed regularly during this period.

Moyle Street Kerbing

In the 2017/18 budget Council adopted a separate rate for the residents adjoining Moyle Street for an upgrade to the road by installing kerbing which will be in place for a 5 year period. This will be the third year of the application of this rate (\$195 per allotment per certificate of title).

Olive Parade Kerbing

At the Council meeting 6th September 2017 the Council supported the motion to install kerbing for properties adjoining Olive Parade, New Town in the 2019/20 budget at the rate of \$164 per allotment per certificate of title. This rate will be applied over a 5 year period ending in 2022/23.

Service Charge

The annual service charge is budgeted to increase by 3.2% per property unit to \$534, in respect of all land to which the Council provides or makes available the Community Wastewater Management scheme.

Adoption of Valuations

Council will adopt the valuations made by the State Valuation Office as provided to the Council in June 2019. Council has no role in this process. It is also important to note that the lodgement of an objection to the Valuer-General does not change the due date or amount for payment of rates.

The Year in Review 2018/19

The 2018/19 financial year saw Council continue to focus on the renewal and replacement of infrastructure such as CWMS, roads, footpaths and drainage.

A commitment to complete the major projects and also continue to include upgrades to CWMS treatment plants and major infrastructure, capping of the closed Wallaroo & Moonta landfill sites, partnering with DPTI to upgrade Mines Road, Stormwater plans, continuation of the Footpath program and Foreshore Upgrades (including Port Hughes Boat Ramp) have been in the works program in 2018/19.

The significant works on the Kadina CBD are also nearing completion with a few minor works to be finalised. This included the upgrades to the Education precinct and the completion of new duplex units, amenities and camp kitchen at the Wallaroo Holiday Park.

Consultation on the Moonta CBD Master Plan, the Strategic Plan and the Bay Road project at Moonta have commenced with the plans looking to be finalised in 2019/20 also and where relevant the work to commence.

Key changes to the ABP and Budget resulting from the Public Consultation

- Council will continue to work with the State Government (DPTI) for the reconstruction of Mines Road from Agery Road through to the 80km/hr sign past Martinga Road.
- Council will continue with its application to the State Government for a road swap for the entrance road to Wallaroo so that this road can be upgraded.
- Council will prepare grant applications for funding to repair the Wallaroo Breakwater.
- Council will also formalise ownership for the Wallaroo to Moonta Rail Trail for walking and cycling.
- Council will continue to provide additional Garbage and Green Waste services based on the rates set in the fees and charges schedule and look to implement a free monthly garden green waste kerbside collection to residential properties as funds become available. This is additional to the implementation of a green waste voucher system to allow residential ratepayers to deliver two domestic loads of free clean organic garden green waste per year to the Resource Recovery Centre under the supervision of staff.
- It is also intended for Cemetery Management Plans to be produced for the four Council cemeteries in Kadina, Moonta, Wallaroo & Greens Plains.

Project Priorities and Capital Expenditure

Project priorities to be undertaken during the year ending 30 June 2020 are as follows:

- Continuous review of existing recurrent service levels provided to be undertaken in consultation with our community;
- Finalise the designs and begin the reconstruction of Bay Road and Frances Terrace including improvements to the cycleway and stormwater. (Note: this is a multi-year, multi-budget project)
- To continue to work with the contractor (at their cost) to reinstate the pontoons and access within the Wallaroo Swimming Enclosure.
- Finalise the Moonta CBD Master plan and begin the implementation of minor works. (Note: this is a multi-year, multi-budget project)
- Repair the sea walls at Moonta Bay and Port Hughes. (Note: this is a multi-year, multi-budget project)
- Facilitating the future financial sustainability of Council by ensuring the financial operations remain within policy targets adopted for such purpose;
- Consolidation of Council's annual works program with a commitment to fund road reconstructions and reseals, footpaths, walking trails and foreshore developments;
- Continuation of the development of storm water management plans along with maintenance and renewal of storm water infrastructure.
- Review Waste Services to ensure sustainable operations into the future by implementing a weigh in/weigh out system when funding becomes available.

All uncompleted projects and their funding allocation currently included in the 18/19 budget will continue and form part of the 19/20 works program.
