APPLICATION FOR DEFERRAL OF RATES (COVID19) - 6 MONTHS FROM 2 APRIL, 2020

At the Council Meeting dated 1st April, 2020 it was decided to assist those ratepayers who are experiencing financial hardship as a direct result of COVID19. This will be a deferral of Council rates for a 6 month period with no fines/interest applied during that period. This deferral will only apply to current rateable properties with the balance being payable in full at the end of the 6 month period. The deferral is subject to the completion of this application.
