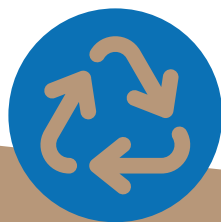


CONDITIONS OF ENTRY

FEES & CHARGES

BUILDING MATERIAL INC ASBESTOS

The Resource Recovery Centre (RRC) is not EPA licenced to receive asbestos. Council resolved at the May 2020 meeting that the RRC would not accept building material (including any concrete materials, tiles, bricks or asbestos-look alike sheeting material), rubble, rocks (greater than 50 mm) or pavers from residents, businesses or contractors.

To dispose of these items, contact MA Skinner Earthmoving Sand and Metal Supplies (Wallaroo) on 08 8823 3466.

Any asbestos sheeting material hidden deliberately within other waste delivered to the RRC will be banned from accessing the site and legal action taken.

GREEN WASTE

Residents are entitled to dispose of two 6x4 ft level trailer loads of Green Waste, each calendar year, by presenting a rate notice or driver's license with the property address. If someone has been engaged to undertake gardening on your behalf, something in writing is required from the resident. Residents who rent will need permission from the owner, however, driver's license with property address will be sufficient.
